## Guide exposed to rabies from bear

Johnnie Dale, owner of Buffalo Creek Guide Service in Sampson and Hyde County, underwent rabies vaccinations after handling a black bear in Hyde County. He found the listless bear

on Sunday, Dec. 16, 2018. "I was filling feeders

and he was lying beside

one." Dale said. "He weighed 85 to 90 pounds and was alive, but non-responsive.

www.mikemarshoutdoors.com Ichecked him again at 7 p.m. He was breathing and moving his eyes but not moving his legs. I pulled out his tongue to check his throat,

but could not find anything

wrong with him." On Monday, Dec. 17, the bear was dead. Dale called N.C. Wildlife Resources Commission Bear and Furbearer Biologist Colleen Olfenbuttel. She arranged a meeting with Biologist or the County of Columbus Kimberly McCargo at Lake Mattmuskeet, who transported it to the Edenton office. On Tuesday, Dec. 18, District 1 Biologist Chris Turner performed a necropsy. On Wednesday, Dec. 19, Turner sent samples to the Southeastern Cooperative Wildlife Disease Study at University of Georgia. On Friday, Dec. 21, SCWDS notified WRC and N.C. public health officials the bear had rabies.

"Rarely is a black bear's death disease-related," Olfenbuttel said. "Maryland had a positive rabies test in a black bear in 2007 and Maryland had one in 2012. New York reported two positives in 1999 and 2003. Some references also indicated rabies in bears the sale with the balance prior to 1992 in New Jersey

"Colleen told me somebody from the Hyde County Health Department would call," Dale said. "When she did, I said I stuck my hand in the bear's mouth without gloves. She told me she would call back."

The follow-up call advised Dale to go to a hospital immediately because he was nection with this foreclosure at the end of the five-day period following exposure when rabies immunizations

"I did not know where to go and it was Saturday night at 11 p.m.," Dale said. "I called Wake Med and they said it would have to wait until the following day. The lady at Hyde County Health Department called again and said it was urgent to get a shot that night. I drove to

Johnson Memorial Hospital while she made arrangements. I had rabies vaccine in the arm, two antibiotic in-

jections in the hip and two in my butt. They said I would have to come back in a week for a rabies vaccine booster and two weeks later for another booster."

Over the summer, Dale saw eight dead raccoons. Game camera images showed the bear with raccoons at a feeding trough. Another game camera nearby had images of the bear fighting another bear.

"Other than scratches on its nose, the dead bear had no wounds," he said. "I killed the other bear and put its head and meat in my freezer. I will have that bear tested for rabies.'

When Dale was fur trapping in the 1990s, he had rabies vaccinations. However, he let them lapse.

"I should have kept getting boosters to maintain my immunity," he said. "From now on, I will wear rubber gloves whenever I handle an animal."

"We don't know how the bear was infected." Olfenbuttel said. "It had scratches on its nose, so it could have been bitten by a rabid raccoon. It could have contracted rabies through eating corn covered with saliva from a raccoon with rabies.

"Johnnie opened the bear's mouth with his bare hands and had cuts on his hands. The normal mode of transmission is through a bite or open wound. You should never handle a dead animal with bare hands and vou should wash vour hands after field dressing any animal."


