Smaller school districts

and New Jersey (2,300) for not understanding the need to combat educational disparities isn't going to cut it. Disadvantaged students in those states perform very highly by national standards. And even among Southern states, North Carolina's districts are significantly larger than those in Virginia (9,700), Georgia (9,400), South Carolina (8,800), and Tennessee

(7,400).

Here's a fundamental reality progressives have yet to accept: regardless of how big the district may be, the days of busing larger numbers of kids around according to race- or income-based school assignments are over. Most parents, of all backgrounds, do not support it.

A more constructive approach would be to get ahead of the trend. Subdi-

vide the largest districts thoughtfully, minimizing any disparities, while ensuring that state and local funding formulas send more money to districts with higher rates of poverty or special needs.

Mr. Charles was well known in Columbus County for the many years he put in as an employee of the County Soil and Water agency. If you see Diane, I know she would appreciate your words of comfort and encouragement.

Former Fire Chief and Town Councilman Jerry Watts also passed away last week. Mr. Watts was a fireman and Chief for decades and he answered literally thousands of emergency calls during his career with the fire department. He also served two separate terms on the

town Council—once in the 1980s and once in the 1990s.

Jerry has many friends and family in our area, and we also offer our sympathy and condolences to all of these loved ones.

Recent wet weather has put a tremendous amount of water on to the ground over the past several weeks.

Although the weather has been unseasonably warm, it really has been too wet for construction to take place. As a result, there are many road repair projects that have fallen behind schedule. The Town has contracts out for street resurfacing, street repairs in the western portion of town associated with a sewer line project, and we also have some street repairs associated with the apartment utility project near the athletic complex.

All of these projects now go into the winter months where it is possible that it might be

too cold for the asphalt plants to operate. We have asked our contractors to monitor the weather and be prepared to put down pavement as soon as it is realistic to do so.

Last week, I attended a retirement party for our going Fire Chief Jerry Hodges. At that occasion, the town announced that we will be naming the Sandy Plains satellite station in honor of Mr. Hodges.

Several years ago, we agreed to name the downtown fire department headquarters building in honor of former Assistant Chief Don Hughes. Council felt it was only fitting to name a station building after our first full time Chief, Jerry Hodges.

Folks in the Sandy Plains area can expect to see signs being put up on the side of the fire station building there in the next month or so. This is just one way of saying a word of thanks to Chief Hodges for a job well done.
