

Mom accused in Christmas beating of a TC toddler

An alleged Christmas day beating that sent a 2-year-old girl to intensive care prompted the arrest of her mother last week.

Alaina Monroe, 24, of Spivey Ward Drive, Tabor City, was charged Friday with child abuse neglect resulting in serious bodily injury, a Columbus County Sheriff's Office report said.

Monroe was released from the Columbus County Detention Center on Friday under a \$25,000 bond. She is accused of neglecting to provide the medical care necessary for her daughter, identified as K.A.M., who "suffered from severe bruising about the body, a broken rib located on her right side, seizures, and bleeding from the brain," the warrant obtained by Det. Samantha Hickman said.

Deputies were contacted just after 3 a.m. on Christmas day that the child had been taken by private vehicle to Grand Strand Regional Medical Center in Myrtle Beach, a report said. The child, who has since been released from the hospital, spent four days in the intensive care unit at another hospital, The News Reporter reported.

An investigation by the sheriff's office and Columbus County Department of Social Services is ongoing.

A Loris area man facing attempted murder charges remained in custody this week.

Hakeem Tequan Bennett, 21, of Airport Road, Loris, was charged with two counts of attempted murder in an Oct. 23, 2018 incident investigated by the Horry County Police Department, arrested Jan. 2 by the Horry County Sheriff's Office.

Bennett remained in custody at the J. Reuben Long Detention Center near Conway under a \$25,000 bond, jail records show.

HCPD officers were called to Bennett Loop Road about 3 p.m. last Oct. 23 and were told by a woman there that her boyfriend who is the father of her child shot two rounds into her car as she was trying to drive away following an argument, the report said.

The woman told police her baby was also in the car. No one was hurt, at least one bullet hit the front left tire of the car, the report said.

You win some, you lose some, would seem to be the experience of a Tabor City man who says he won \$100 playing a video game at one local convenience store, only to be told the bill was counterfeit at another branch of the same business.

Robby Lee Turner, 54, of Carolina Trace, said he won \$130 playing an electronic video game at the Vasco #1 on Fair Bluff Road, in Tabor City, including a \$100 bill, then traveled to the Vasco #2 on East 5th Street to play a video machine there, the Jan. 5 report by Lt. Robert Mumblow said.

But when he tried to spend the \$100 bill at the second store the clerk spotted it for a counterfeit, and would not accept it, Turner said.

Returning to Vasco #1, Turner spoke to a clerk, who called the owner, who said he could not immediately come to the store, the report said.

Police took the bogus bill, and asked Turner to let the TCPD know if Vasco gave him another \$100 in its place.
