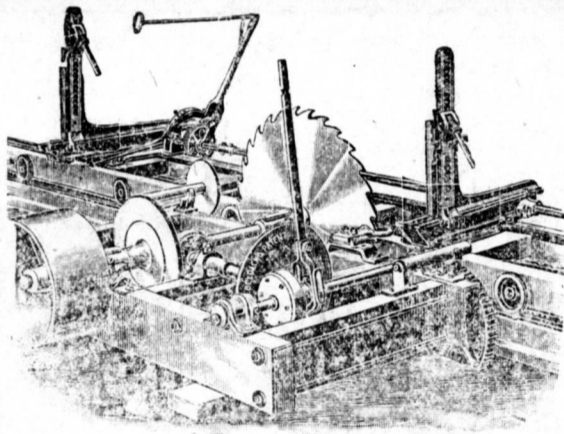

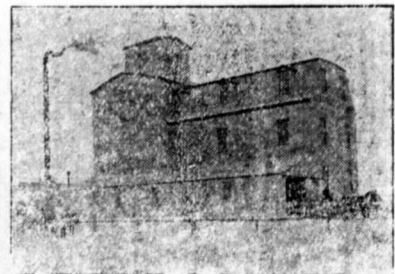

Ole J. Loumen, Carl Molstad and Ole Aae were up to Quam's mill Tuesday after lumber to be used for the building of a church here next summer.

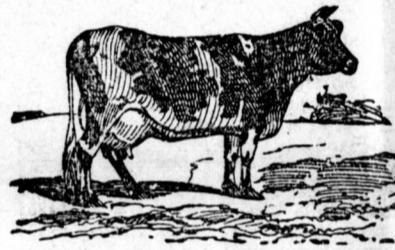

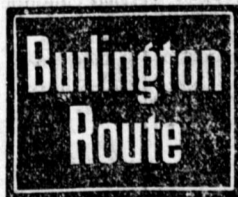
