## Smith & Burnett continues to serve the community, surrounding area

The history of the law firm of Smith & Burnett, L.L.C., commenced in Larned's frontier days. The practice of George W. Finney's began in 1885 as the foundation of the firm. Finney was later joined in the practice in 1933 by Maurice Wildgen.

The Finney and Wildgen period was during the heyday of small town solo and dual practice. Glee Smith, Jr. began his association and partnership with Maurice Wildgen in 1947, which was George Finney's last year in practice. Subsequently, Glee Smith embarked on long political career that included serving as president pro-tem of the Kansas Senate.

Donald Burnett became a partner in Wildgen & Smith in 1958. The firm became know as Smith & Burnett in 1963 when Maurice Wildgen was elected as Pawnee County District Court Judge. Following the addition of Jerry Larson in 1975 the firm name became Smith, Burnett & Larson. Ronald Smith joined the firm and became a partner in 2009. In 2012, Jacque Butler became a partner and the firm's name changed to

Smith, Burnett, Larson & Butler.

The firm is currently known as Smith & Burnett as Jerry Larson is now "of counsel" and Jacque Butler has relocated.

Although the name has changed several times over the course of 131 years, Smith & Burnett continues to serve the community and the surrounding area in general practice, estate planning, trusts, probate, guardians, conservatorships, real estate, oil and gas, and municipal law.
