Loy signs with WKU golf

Russell County High School Lady Laker golf standout, Lizzie Loy, signed a National Letter of Intent, with Western Kentucky University last Wednesday afternoon during a private ceremony at the school.

Loy, who will graduate from RCHS in May 2018, helped lead the Lady Lakers to a regional championship and a top-10 finish at the state tournament this fall.

"This is definitely a day I've worked for and dreamed about since I was little so to be able to share it with friends and family means so much," Loy said.

"It is such an exciting day and something I've ultimately worked for all my life. To see that I've accomplished it means a lot."

Loy said she was proud of how her Lady Laker golf team competed this past season.

"We set goals and we accomplished them so I think that's what really led to my individual success," she said.

"I wasn't worried about what I did myself, I was worried about how we did as a team."

RCHS Lady Laker golf coach Greg Coe said it had been a pleasure to coach Lizzie this past season.

"I look forward to her going to Western," he said. "She is going to be very successful. She's a very hard worker and has had a lot of success at the high school level, junior golf and anything she has participated in."

Coe said it was a big honor to sign with an NCAA Division

One school like WKU.

"Lizzie will represent Russell County High School really well at the next level," he said.

Loy, who was recently named first team all-state, said her most exciting moment of the season happened at Eagle's Nest, where she shot a 67, or her play in KIT at Lakewood Country Club.

She chose WKU over other schools because it was where she had always dreamed of attending college.

"When I got the offer and opportunity to play there it was really a dream come true," Loy said. "I'll be there next fall."

Loy said she plans to major in exercise science and one day wants to be a physical therapist.
