

## SCAR News One Last Green Flag

Going into Sunday's race at Phoenix only one spot remained to fill the four-driver field that now advances to the final race at Homestead-Miami with the opportunity to run for the title. Kyle Busch, Martin Truex Jr. and Kevin Harvick had already punched their ticket into the final race by their performances during the Round of 8 races at Martinsville and Texas but for the remaining five drivers there was still a chance for each to advance. Brad Keselowski entered the race in the fourth spot to advance because of his position in the points

but a poor qualifying effort had him starting 16th which was the lowest of any of the five remaining

drivers still in the playoff hunt. His point lead was enough above the cutoff line that unless one of the remaining four drivers won the race that he could put together an average finish and still have a great shot at advancing. It seemed that his average finish would not be good enough on Sunday as Ryan Blaney sat on the ole with Denny Hamlin starting second followed by Chase Elliott in fourth. Seven-time champion

Jimmie Johnson started twelfth but like Blaney and Elliott, he was so far back in the points that it would take a victory by any of the these three drivers in order to advance. Just before the end of stage two, Johnson cut a tire and hit the wall which took away any chance

he had of winning. Hamlin backed up his second starting spot by winning the second stage and becoming the dominate car on the day as he led 193 laps on the day. Blaney was falling back through the field by this time and Elliott was still running strong while Keselowski stayed in the middle of the pack but more importantly for him was staying out of trouble. On lap 270, Elliott and Hamlin replayed their now famous contact from Martinsville only this time

it was Elliott on the bumper of Hamlin. Elliott used his bumper to move Hamlin up the track and the two eventually got together with Hamlin making enough contact with the outside wall that he had to take his Toyota to the garage. Elliott looked like he was on cruise control for the win but was passed by Matt Kenseth in the closing laps who went on to win in his next to the last start for Joe Gibbs Racing. Hamlin's exit from the race combined with Kenseth's win gave Keselowski who finished 16th the final remaining spot in the Championship Four. Keselowski joins one of the strongest fields ever to go to Homestead with a chance to win the title.

Keselowski, Harvick and Busch are all former champions and they will be joined by the season's hottest driver in Truex Jr. who leads all drivers this season with seven wins.

The rules now change from what has been used in the opening three rounds of the 10-race playoffs. All four drivers will have their points reset to 5,000 as bonus points no longer carry over into the next round. Unlike every race this season no stage points will be awarded to any driver.

The simplification of the rules makes it easy to determine this year's champion as he will be the driver of the four that finishes the highest in the race. That makes the racing that we see on Sunday unlike what we have seen all season long as stage racing changed the strategy that crew chiefs used It was all about getting points, stage wins and race wins but that line of thinking becomes a distant
