 gency services or routine care. We should continue to build on these successes.

### Broadband Creates Jobs

Like health care, high-speed mobile broadband is important to a community's vitality and economic growth. As chairman of the Senate subcommittee that oversees telecommunications issues, I have remained focused on eliminating the digital divide between rural and urban areas. Mobile broadband can open a number of doors for new jobs, along with improvements in education and public safety. In Mississippi, access

to reliable broadband can give patients telehealth options and enable our farmers to maximize their crop yields through precision agriculture. Earlier this month, I wrote to Ajit Pai, the new chairman of the Federal Communications Commission, reiterating the need to make mobile broadband accessible to all Americans. You shouldn't have to live in a city to benefit from the latest technology.

Of course, mobile broadband is not the only driver of economic development. Like other infrastructure upgrades, safe drinking water and wastewater systems can also significantly impact quality of life in both urban and

rural areas. Environmental Protection Agency regulations can be excessively burdensome for smaller localities. I look forward to introducing legislation that would authorize competitive grants to support public wastewater utilities in need of technical assistance. This is similar to my legislation that became law in December 2015 for drinking water systems.

Our country's long-term success is tied to the well-being of all Americans, from coast to coast and all the cities and small towns in between. I am hopeful that the Administration continues to empower rural communities to thrive.
