We are actually more than seventy percent water ourselves.

The presence or absence of water is the single most important factor in the production of crops. It transports nutrients to the plant for use in building all of

The transpiration of water vapor through stomates not only cools the plant but also provides the negative pressure required to maintain the flow of water containing vital elements from the soil.

We seldom see pure water because it dissolves so many substances. If we want pure water we have to prepare it laboriously by such means as distillation, ion exchange, and reverse osmosis. Moving water dissolves rock to form caves and to wear away mountains. All of the water on Earth, therefore, is in the form of solutions. The dissolved substances change the properties of water from what they would be in absolutely pure water.

June 26 deadline approaching for 2016 drought assistance

The U.S. Small Business Administration is reminding small businesses, small agricultural cooperatives, small businesses engaged in aquaculture and most private nonprofit organizations that June 26 is the filing deadline for federal economic injury disaster loans in Mississippi as a result of the drought that began on Oct. 18, 2016.

This disaster declaration includes the following counties: Attala, Calhoun, Carroll, Chickasaw, Choctaw, Clarke, Clay, Grenada, Holmes, Humphreys, Jasper, Kemper, Lafayette, Lauderdale, Leake, Leflore, Madison, Montgomery, Neshoba, Newton, Noxubee, Oktibbeha, Pontotac, Webster, Winston, Yalobusha, and Yazoo in Mississippi.

Under this declaration, the SBA's Economic Injury Disaster Loan program is available to eligible farm-related and nonfarm-related entities that suffered financial losses as a direct result of this disaster. With the exception of aquaculture enterprises, SBA cannot provide disaster loans to agricultural producers, farmers, or ranchers. Nurseries are eligible to apply for economic injury disaster loans for losses caused by drought conditions.

The loans are for working capital and can be up to \$2 million with interest rates of 4

MEMA advocates preparedness for 2017 hurricane season

As Hurricane Season begins next week, the Mississippi Emergency Management Agency wants to remind all Mississippi residents to begin preparing for the 2017 Hurricane Season.

As part of Mississippi's Hurricane Preparedness week, MEMA Executive Director Lee Smithson reminds Mississippians to discuss their Family and Business Disaster Plans. The plan should include an evacuation method and route, a communications plan and a disaster supply kit.

"I think it is safe to say that every Mississippian was affected by Hurricane Katrina 12 years ago," Smithson said. "Just because we haven't had a major hurricane in several years, doesn't mean that it won't happen this year. Now is the time to start planning for such an event."

Residents should contact their county emergency management directors to learn about emergency plans for their area, locations of shelters and evacuation zones and routes. For a full list of contact information for county emergency management directors, go to <http://www.msema.org/local-ema/>.

Following an evacuation, a

communications plan can help residents locate family members and friends who also evacuated. During and after a storm, telephone service could be limited. It is often easier to call long distance, outside the disaster area, or to even send a text message from a mobile device or from social media.

Ask an out-of-state friend or relative to serve as the family contact person.

Make sure all family members know the name, address and telephone number for this contact person.

Develop and maintain a Family Disaster Supply Kit with life sustaining items such as:

Non-perishable food and water for at least three to five days.

A first aid kit with prescription medications.

A battery-powered radio, flashlight and extra batteries.

Cash and traveler's checks.

Specialty items such as baby formula and pet-care items.

If you evacuate remember to take your supply kit with you along with other things like bedding if you are going to a shelter. For more information on important items to include in a disaster supply kit, go to <http://www.msema.org/be-prepared/disaster-kits/>
