(Continued from page 1.) nephew's residence on Wash Bailey Road, all according to a sheriff's department report.

On May 13 a resident on MS Highway 17 South reported items taken from his home, a gun safe valued at \$900, 13 rifles valued at \$3,000, eight hunting lights valued at \$800 and an F-150 key, all according to a sheriff's department report.

On June 5, a resident on MS Highway 17 South in Pickens reported her back door had been pried open and eleven guns valued around \$4,674 taken, all according to a sheriff's department report.

On June 12, a resident on Hebron Road in Lexington reported after returning home from work, noticed six guns missing from a gun safe in his master bedroom. No value was written on the report. It was reported that a window was broken out of a bedroom in the back of the home, all according to a sheriff's department report.

On June 16, a resident on Rosebank-Mt. Olive Road in Lexington reported a Sanyo 32" television valued at \$136.96, two .22 rifles and a .38 pistol stolen, all according to a sheriff's department report.

On June 17, equipment, materials and tools were reported stolen from a farm three miles outside of Lexington on Brozville Road. A lock was reported cut off the gate to gain entrance to the property. Reported stolen was a Honda 1500 generator valued at \$1,500, nine rolls of barbed wire, seven bundles of fence key posts, eight load binding straps, 20 tie down straps, a rim and tire and two 8-gauge extension cords, all according to a sheriff's department report.

Two arrests were made in connection with the burglaries on MS Highway 17 south in Pickens and Rosebank-Mt. Olive Road in Lexington. Kenji Friar, 29, of Lexington and Randy Skinner, who was reported as the driver, were being held at the Holmes-Humphreys Regional Correctional Facility as of Monday, June 19. Bond had not been set at that time.

Holmes County Sheriff Willie March stressed the importance to property owners to ensure serial numbers, registration numbers and similar records are maintained for valuables in order to expedite recovery and the return of valuables like guns and four-wheelers to the rightful owners.
