September is the month of is only a continuation of the highest frequency for tropical storms in Mississippi followed by August and October. The arrival of tropical storm Cindy was a real surprise for everyone around here, especially farmers with crops needing to be treated for weeds and pests. Many fields of late planted cotton were still emerging when the deluge began and every farmer knows that saturated soil conditions are the arch enemy of stand establishment for any crop but particularly cotton.

Prior to the storm our area had received abnormally high rainfall which set the stage for some of the wettest field conditions we have experienced in many years. I realize there are many people who will prefer to assign the credit for this weather to climate change but for me it

When soil reaches "field capacity" a chain of events is triggered which can produce effects ranging from mild to devastating. The first thing is that gaseous oxygen is both pushed out by water and tied up by the oxidation of mineral elements. Essential elements like nitrogen are oxidized. Other elements such as arsenic remaining in the soil from earlier times may be reduced to toxic forms that can damage roots and reduce yields.

soil saturation affects living organisms both beneficial and otherwise. Good organisms like the rhizobium bacteria that fix nitrogen for soybeans along with mycorrhizal fungi and other beneficial organisms are suppressed since the oxygen they need is limiting. Bad organisms like parasitic nematodes may actually be suppressed as well.

saturation and tillage system. In my opinion there is little doubt that reduced tillage and/or notillage systems tolerate this kind of weather better than intensive tillage systems since the conservation type systems contain much more porosity to allow for improved internal drainage. These less-disturbed soil are also more extensively aggregated, allowing them to hold onto more oxygen following the high rainfall events. We will see less negative impact to crops in these fields than in intensively tilled fields, especially with regard to recovery of the crop following the period of saturation.

For those who are aware that I have been out on medical leave I must say that I cherish all the prayers, messages, and concerns over my recovery from surgery. This has been an experience that I will never forget in many ways, but mostly in good ways.
