Lexington man dies in highway 17 crash **Staff Reports**

Mississippi Highway Patrol is still investigating a two-vehicle crash, in Holmes County, that claimed the life of a Lexington resident.

Troopers responded to MS 17, near Lexington, at approximately 8:45 p.m., Sunday, June 25. Upon arriving it appeared Clarence Buchanan, 64, of Lexington, was driving a 1997 Buick and attempting to turn onto MS 17 from Busy Bee Road, when he apparently pulled into the path of a north bound 2010 Chevrolet, driven by Charmesha Blair, 31, of Lexington.

Buchanan received fatal injuries in the crash and died on the crash scene. Andrew Marshall, 67, of Lexington, was a passenger in Buchanan's vehicle. He received life threatening injuries in the crash. He was transported to a local hospital and is listed in critical condition.

Blair and two children in her vehicle received moderate injuries from the crash.

Meeks advances to Georgia horse championship, quiz bowl team ranks fifth in state

The State 4-H Horse Championships were held last week at the Fordice Equine Expo in Jackson. Club 4-H youth from all over the state came together on the Fairgrounds to compete during the week-long event.

Educational contests included Hippology, Horse Judging, Horse Bowl (quiz bowl), Individual and Team Demonstrations, and Public Speaking. In addition, horse art and photography were on display. Horses were shown "in-hand" in Showmanship and Halter classes, ridden in Pleasure, Trail, Ranch and Speed classes, as well as,

Goat Tying, Boxing and Roping. All sorts of equine were shown from Mini's and ponies to Quarter horses and Saddle and Gaited.

Holmes County 4-H'ers participated in a variety of these contests - earning (most notably) one of the coveted slots to advance to the Southeast 4-H Regional Championships.

Tredell Meeks, Jr. qualified on his horse Daisy in Pole Bending and will represent Holmes County and Mississippi in Perry, Georgia, from August 2 through 6. Though Tredell was our lone regional qualifier, his was not the only outstanding performance by our youth. On Tuesday, our Junior Horse Quiz Bowl team placed 5th in the statewide competition. Members of this team were Sinatra Clayton, Colton and Livi Howell and Marquail Primers. Then on Thursday, they also performed well in Goat Tying, Calf Roping and Ranch Sorting. Livi Howell placed 5th in Goat Tying while Jewel Vandevere won and brother, Garrett, placed 3rd.

In Breakaway Roping, Javontae Jefferson placed 8th and Jay Jay McCaskill placed 5th. Jay Jay and partner Austin Roebuck placed 2nd in Dally Team Rop-

In Ranch Sorting, Anthony and Tredell Meeks penned two head in 76.78 seconds before losing a couple of head through the gate to a "no time." Austin Roebuck and Jay Jay penned one in 28.55 seconds before losing more calves through the gate to a "no time."

Friday was the day for halter classes. Tredell took 2nd in Grade Western mares with Daisy and Darien Polk, 4th. Emma Cotton placed 9th in Showmanship with her pony and 2nd in her Pony Mare class. She, also, placed 4th in Pony Pleasure. Jay Jay placed 7th in Saddle Horse (Continued on page 7.)

County schools to see advanced placement classes made available for 2017-2018 school terms

Mississippi State University is helping facilitate a program that will allow students in rural Mississippi school districts to take Advanced Placement courses from leading American

Beginning in the 2017-2018 school year, the Mississippi Public School Consortium for Educational Access is implementing a pilot program to teach Advanced Placement subject matter in select rural and low-income school districts which currently do not offer the

As part of the program, over 20 students from seven participating school districts are taking part in a two-week preparatory summer academy for AP physics at MSU.
