AN ORDINANCE OF THE MAYOR AND BOARD OF ALDERMEN OF THE CITY OF DURANT, MISSISSIPPI PROVIDING ILLEGAL DUMPING

Whereas, the City of Durant, Mississippi has an interest in the beautification of our community and to enforce the following re-

NOW THEREFORE BE IT ORDAINED by the Mayor and the Board of Aldermen of the City of Durant, Mississippi as follows,

It shall be unlawful within the incorporated municipal limits of the City of Durant for any person to dispose of trash or rubbish or garbage or any solid waste by burning, burying, dumping on the ground, or dropping off at an unauthorized place such as public or private property, streets or alleys, ditches, or storm water drainage system. IIlegal dumping shall include, but not limited to, the unauthorized storage or disposal of concrete, bricks, or asphalt on a vacant lot, field, wooded area, or storm drainage

Article II

Dumping of hazardous, toxic or specia waste within the municipal limits of the City of Durant is strictly prohibited. (Define "special waste")

Article III

There shall be no dumping or placing of any concrete, bricks, or asphalt, hazardous. nonhazardous material resulting from construction, remodeling, repair, or demolition or utilities, furniture, computers, televisions, etc. on any property within the city limits.

The person or persons that illegally dumped shall be guilty of a misdemeanor and shall be punished by a fine not exceeding \$1,000.00 or by imprisonment, not exceeding ninety days, or both, to be enforced in the Municipal Court of Durant,

Article IV

The City of Durant, through its Code Enforcement Officer, shall notify by first class mail the owner and/or occupant of any property, residential and business, that is violation of this ordinance. If the Code Enforcement Officer cannot notify the owner or occupant of the property then notice may be posted in a conspicuous place on the property. The person that illegally dumped or owner or occupant shall be given five days

in which to correct the violation.

If the owner or occupant does not correct the violation within the five days, the owner or the occupant shall be guilty of a misdemeanor and shall be punished by a fine not exceeding \$1,000.00 or by imprisonment, not exceeding ninety days, or both, to be enforced in the Municipal Court of Durant,

Article V

All ordinances or parts of ordinances in conflict herewith are repealed to the extent necessary to give this ordinance full force

Article VII

This ordinance shall take effect on and be in force thirty (30) days after its publication.
