# Widower of former poll worker considers litigation against county

#### By Matthew Breazeale

On November 7 of this year, Durant resident Harold Payton will be honoring two anniversaries. Fifty-nine years of marriage to his wife Jo Nell and one year since her death.

Payton's wife Jo Nell was working as a poll worker for Holmes County on the night of Monday, November 7, 2016. She was reportedly carrying ballot boxes from the second floor courtroom down to her car in preparation for November 8 Election Day. Jo Nell allegedly fell down the inside steps of the Holmes County Courthouse, hitting her head which led to her subsequent death. She was Greenwood hospital after no brain activity.

Payton is accusing the county of dismissing the incident by its silence of the matter.

"That day we were supposed to go out and celebrate our anniversary, we had been married Jo Nell. I said no, but I'm getfifty-eight years the seventh of ting worried about her. He said November," said Payton. "And that happened at nine that night (Monday). She was working for

the county, over there picking up stuff for the election," set for the following day.

Payton said he got a sense that something wasn't right with the pronounced dead days later in situation when he "never did hear nothing from them! Nobody called me that night and told me about the accident until David Truitt, a friend of ours, called me. He lives down the road. He called me at 10 o'clock and asked me had I heard from 'Well, get your daughters to pick you up and bring you to Greenwood. She's had an acci-

dent and it's bad.'

'So that's what happened," Payton continued, "we got to Greenwood at 12 o'clock. This (incident) supposedly happened around 9:00 or 9:30. When we got up there they never did interview none of the family, they didn't ask us anything (about the fall), didn't ask us for any names, didn't ask us to sign nothing. (The hospital) got her wallet and got her Medicare card which is what they started charging to, I don't know who approved that. They had her in the operating room when we got there."

The family was finally able to lay eyes on their matriarch around 2 a.m.

"They came out carrying her down the hall, had her head covered up," said Payton. "I told the kids 'That's not good.' The doctor came in after he got cleaned up and said 'Well I've done all I can do tonight, I couldn't close up because of brain swelling. When we get her in the room, hooked up, y'all can go see her. When we (Continued on page 2.)

# **Anti-overdose medication now** available to law enforcement, public

### **Staff Reports**

The Mississippi Department of Mental Health (DMH) has partnering with the 21st Judicial District Drug Court Program to provide naloxone, a lifesaving medication that blocks or reverses the effects of opioid overdoses, to all law enforcement agencies in Holmes, Humphreys, and Yazoo Counties.

Training was held on Octo-

ber 6, in Lexington, by the Budations made by the Governor's reau of Alcohol and Drug Services within DMH to provide the naloxone through funding provided by the State Targeted Response to the Opioid Crisis grant awarded as part of the 21st Century Cures Act passed by Congress in December 2016.

This partnership with local law enforcement agencies is consistent with final recommenOpioid and Heroin Study Task

Michael Jordan, the State Opioid Treatment Authority with DMH says that, "The abuse of prescription drugs has led to a surge in opioid and heroin addiction, and this is an issue that is costing people their lives."
