# General election is planned for June 6

The Clinton Courier

Clinton's voters will go to six locations to vote in the general election, set for June 6. Polling sites will be open from 7 a.m. until 7 p.m.

Clinton municipal election voting sites include Ward 1, Federation Towers; Ward 2, Wildwood Baptist Church; Ward 3, National Guard Armory; Ward 4, Wood Activity Center; Ward 5, First United Methodist Church; and Ward 6, Holy Savior Catholic Church.

Candidates on the ballot for June 6 will include incumbent Mayor Phil Fisher, a Republican who has held the office since 2013, running unopposed.

Fifteen candidates for alderman have qualified, with only Ward 3 Alderman William "Bill" Barnett unopposed for reelection after the qualifying deadline.

Ward 1 incumbent David Ellis, a Republican, will face Janice McQuirter, a Democrat.

Ward 2 incumbent Jim Martin, who beat Republican challenger Christopher Lay in a primary on May 2, will face Democrat Cedric Morgan in the general election.

Ward 4 is an open seat this election cycle, with incumbent Alderman

Greg Cronin not seeking reelection. Two candidates will be on the ballot on June 6: Democrat Bernard Kines and Republican Keith Perritt.

Ward 5 incumbent Jan Cossitt will face Vera Watson, a Democrat, and Ronald Morris, a Libertarian.

Mike Cashion, the Republican Ward 6 incumbent, will run against Jeffrey Hammond, a Democrat.

The Alderman-at-Large position is being vacated by long-time Alderman Jehu Brabham. Two candidates, Republican Ricki Garrett and Democrat Kenny Lewis, are vying for the position in the general election.

Municipal officers' terms will begin July 1.

Citizens needing to vote by absentee ballot are encouraged to contact the City of Clinton City Clerk's office at 601-924-5474. The office is located at Brighton Park at 530 South Frontage Road.

The City Clerk's office will be open from 8 a.m. to noon on May 27 and June 3 for those registered voters wishing to cast an absentee ballot in the general election.
