

On September 10, 2017 Deputy Kuhn and Sgt. Kruchowski received a report of an assault occurring on September 9, 2017 at approximately 10:00 p.m. Sgt. Kruchowski spoke with AAA, the reporting party.

AAA stated Wade Allan Morris, the above named defendant, was staying at her residence on Wildwood Road, Cass Lake, located in Hubbard County. AAA stated she and the above named defendant have been in a relationship and were living together from July, 2017 through September 9, 2017, attempting to work their relationship out. AAA stated at approximately 10:00 p.m. on September 9th, the above named defendant was intoxicated by alcohol, unbalanced, and antagonistic. AAA stated the above named defendant told her he was going to shoot her, shoot the dog, and shoot himself. AAA stated she told the above named defendant she would call the cops and the above named defendant stated it would be suicide by cop then. AAA stated the above named defendant attempted to get to a pistol/firearm under their bed, but she told him no. AAA stated the above named defendant then pushed her hard onto the bed and she fell. AAA stated she had to push the above named defendant off her after he pushed her. AAA stated she then left the residence and stayed with a friend overnight, before calling 911 on September 10th.

Deputy Kuhn arrived at the residence on Wildwood Road and located the above named defendant in an icehouse/fish house next to the residence. Deputy Kuhn observed the icehouse to be locked, but could see through the windows. Deputy Kuhn made clear commands to the above named defendant but the above named defendant wouldn't comply. The above named defendant responded, "f**k you" when ordered to exit the icehouse. When law enforcement informed the above named defendant he was under arrest the above named defendant stated, "Well someone is going to die then." While law enforcement ordered the above named defendant out of the icehouse the above named defendant drank a beer. When finished with the beer the above named defendant exited the icehouse when promised a cigarette by law enforcement. A preliminary breath test was conducted on the above named defendant with a result of .25.

A check of the above named defendant's criminal history reveals convictions for violation of an order for protection on February 26, 2016 (file 04-CR-16-627) and March 7, 2016 (file 04-CR-16-718). AAA was the victim for both prior convictions.

Ask a Trooper

Question: My father found a wallet at a big retail store while on vacation and was concerned about handing it off to the staff there, instead deciding to contact the owner directly. He was eventually pulled over by local PD, with the wallet in hand, and was told he could be brought up on theft charges. What should he have done? His intent, clearly, was to ensure that the staff at the store wasn't going to pocket any cash from the wallet before putting it in their safe, but that's not how the police perceived it.

Answer: There are two other options that could have been done besides turning the wallet into the store staff. He could had turned it over to a supervisor at the store where it was found. The other option is to report it to the local police or sheriff's department where it was found.

What could have happened in this situation is that the wallet may have been stolen and discarded where your father found it, and it was considered stolen property. By explaining how and where the wallet was found would clear him as a suspect of possessing stolen property. If further evidence is needed, law enforcement could obtain video footage from the store and that would support his statement.

We have had wallets, purses and property that were found on state highways or freeway that were turned into a trooper or an MSP office staff employee. We would go through the wallet or purse in an attempt to find some form of identification that can be used to contact that person.

If you ever lose a wallet or purse that contains credit cards and a driver's license, contact your credit card companies as soon as you can and report it missing so they can't be used to purchase anything. Contact your state's department of vehicle services and report that your driver's license is missing and a duplicate license can obtain. If the wallet or purse is stolen, report it to your local law enforcement agency where a report will be generated and the items can be returned to you if found.




