Continued from last

Villa Grove News, March 22, 1923 "Five fighting boys with the kind of spirit that never gives up, battled their way through the last trench of opposition Saturday night in the Gym Annex and sent the entire population of Villa Grove back home supremely happy in the knowledge that its team had won the state basketball championship by licking Rockford 32 to 29.

Outweighed by several pounds to the man, the doughty little quintet from Douglas County never quailed in the least before the powerful machine that Rockford sent into the finals. The Villa Grove team out played its opponents during most of the game. Rockford showed flashes of brilliant work, the forward combination doing some pretty good passing under the basket, but two often the shots were too hasty and were made without perfect aim.

Villa Grove played at top speed every minute of the game. Those who expected the smaller men to tire before the game ended did not reckon with the nerve of the youngsters had. The passing and dribbling were fully as good as on Friday night and the guards rose to superhuman efforts to stop the giant Rockford forwards.

Down at Villa Grove this morning those five boys are probably monarch of all they survey with one white-headed lad named Barmore ready to take over the keys of the city. For it was Barmore more than any other that licked Rockford.

Not that the others were not in the game, the work of Combs and Sanders at guards, Reynolds brilliant jumping at center and the great defensive game played by Hulse, al helped, but Barmore was the boy who pulled through when his mates needed the baskets. Eight, count 'em, eight field goals were the amount that the fighting forward clicked through the hoop. And they came mostly when they were needed to bolster a fast tiring

and discouraged team.

It was Barmore who, when the mighty Gleichman and Behr had placed the northerners ahead, tossed two long distance shots that once more put Villa Grove in the lead and silenced the seven Rockford rooters in the stand. It was Barmore who tossed a basket just before the game ended, after Behr had placed Rockford within two points

And though Villa Grove won, too much cannot be said of this Rockford outfit. Forwards like Behr and Gleichman are not often seen in high school basketball. Those who marveled at the passing of Villa Grove might have seen some plays as perfectly executed had they watched Behr and Gleichman a bit closer. The latter is a wonderful floor man in addition to his uncanny ability to pot easy shots. Behr played much the same type of game as Gullion, the great Purdue star.

Although Villa Grove led nearly all the way there was hardly ever more than four points between the teams. The Douglas County boys grabbed a four point lead at the start, but only desperate fighting kept them on the big end of a 15 to 14 score at the end of the half. At the third-quarter mark, they were leading 23 to 21.

Shortly after the last quarter, Behr and Gleichman got busy and shot past Combs and Sanders for enough baskets to give Rockford a five point lead. Wise fans at once conceded the game, thinking the Villa Grove bunch was tuckered out. But not so. Barmore shot two perfect baskets from deep in the court and a second later, tossed a free throw. Reynolds came through with another basket a minute later which made Villa Grove once more ahead.

With the score 30 to 26 and only a minute and a half to play, Gleichman dropped a basket through and the game
