CRIMINAL CHARGES

Donald L. Raney, 37, Tuscola, charged with Class 4 felony count of unlawful possession of controlled substance in that he knowingly possessed less than 15 grams of a substance containing heroin, a controlled substance.

Marlin F. Plank, 36, Arthur, charged with six Class X felony counts of predatory criminal sexual assault of a child in that he committed acts of sexual contact with two minors under age the age of 13 for the purpose of sexual gratification or arousal.

Herschel E. Hooven, 83, Villa Grove, charged with two Class A misdemeanor counts of domestic battery in that he knowingly caused bodily harm to a family or household member and made contact of an insulting or provoking nature with a family or household member.

Derrick L.
