
90th Birthday

Sidney/Homer Peace Meal menu for Thursday, November 16 through Wednesday, November 22.

Thursday, 11/16/17 - Saucy riblet, macaroni and cheese, blueberry muffin served with butter or margarine, warm blackeyed pea salad, apricots, and a half pint of milk.

Friday, 11/17/17 – Salisbury beef patty, mashed potatoes, dinner roll served with butter or margarine, mixed vegetables, fresh fruit, and a half pint of milk.

Monday, 11/20/17 - Roast turkey, mashed potatoes and gravy, dressing, seasoned green beans, peaches, and a half pint of milk.

Tuesday, 11/21/17 – Baked ham, candied sweet potatoes, dinner roll served with butter or margarine, buttered Midori vegetables, pie, and a half pint of milk.

Wednesday, 11/22/17 - Chili with beans, mixed lettuce salad with dressing packet, crackers, Waldorf salad, and a half pint of milk

The Peace Meal Congregate Meal Site in Sidney closed effective August 1, but the home delivered meals program continues Monday through Friday for seniors who qualify and individuals who were attending the Peace Meal Congregate Meal Site in Sidney are invited to attend the Peace Meal Congregate Meal Site in Homer.

Homer Peace Meal is served around 11:00 a.m. Monday through Friday in the Homer Village Hall located at 500 East Second Street in Homer. Home delivered meals are available Monday through Friday for seniors who qualify.

To reserve your spot call Peace Meal at 1-800-543-1770 by 12:00 p.m. the day before the meal you wish to attend. Skim milk and desserts with no sugar added are available in many locations. Ask the site supervisor for more information. Peace Meal sometimes needs to substitute on menus, but still guarantee a nutritious meal.

The Peace Meal Senior Nutrition Program suggests a donation of \$3.50 for each congregate and home delivered meal, however, no older person will be denied a meal because of their inability to contribute to the cost of the meal. The Peace Meal Senior Nutrition Program does accept the Illinois Link Card for payment.

an agreement with Hartman Consultants, LLC to the Monday, December 4 Sidney Village Board of Trustees meeting agenda.

Sidney Village Operations Manager and Water Superintendent Earl Bennett reported that he would provide his report during the Water and Drainage Committee report.

Sidney Village Board Trustee and Finance Committee Chair Cyndi McCloud gave the finance report. A motion from Trustee McCloud seconded by Trustee Jason Arrasmith to pay all of the monthly bills carried. McCloud also reported on her research into whether the Sidney Community Library could be included within the Village of Sidney audit by reporting that the library had never before been included within the village audit, that she needed to look into library finances to see if this were possible, and that she would report back at the Sidney Village Board of Trustees December 4 meeting. Sidney Village Board Trustee and Streets and Alleys Committee Chair John Finn reported that he needed to find out more about how many offices, etc. Village of Sidney board members want to have in a building before he can draw up plans for a new Village of Sidney building to be erected on the villageowned property where the Sidney Grade School used to be.

President White thought two offices and a room for the Sidney ESDA need to be a part of the building. Board members also decided that a conference meeting room with a kitchen need to be included following discussion.

Discussion concerning the adverse effect of moving out of the downtown area was brought up as it is more convenient to have offices in the downtown area. Also brought up was the concept that the current community building could be torn down and a new and slightly bigger building put up in its place. It was additionally mentioned that the downtown Loman/ Ray insurance building could be looked at as a possible temporary location for village offices during construction. Trustee Finn will look into the possible use of the Loman/ Ray building and report back at the December 4 Sidney Village Board of Trustees

have been completed and that letters have been sent to Sidney residents who have meters inside their house asking for access to upgrade those water meters.

Village Board Trustee and Public Property Committee Chair Jason Arrasmith reported that he had received a \$1,540.00 estimate from Leaf It To Us Total Tree Care Plus LLC to grind out 13 tree stumps within the village. Trustee Jason Arrasmith's motion seconded by Trustee Cyndi McCloud to spend \$1,540.00 with Leaf It To Us Total Tree Care Plus LLC to remove the 13 stumps carried. Trustee Arrasmith additionally reported that building permit #701 had been issued at a cost of \$150.00 to Crop Production Services to put up a shed, that building permit #702 had been issued at a cost of \$50.00 to Danny Ennis at 306 South David Street to put up a portable shed, that permit #703 had been issued at a cost of \$50.00 to Eris Hagerman to put up a fence, and that permit #704 had been issued at a cost of \$50.00 to Chris Bromley at 201 Austin Drive to put up a fence. There was no Parks and Recreation Committee report as Sidney Village Board Trustee and Parks and Recreation Committee Chair Tyler Bickers was absent from the meeting. Sidney Village Board Trustee and Community Development Committee Chair Leroy Schluter reported that the village needed to reset the Community Building meeting room clock as it is an hour behind and that he had heard positive feedback from Sidney residents that the 5:00 - 8:00 p.m. trick or treating had gone well. Trustee Schluter also announced that the Sidney Village Board of Trustees will have a 6:30 p.m. village board meeting regarding zoning on Tuesday, November 14 at the Sidney Community Building. The meeting agenda is in regards to the property owner of 202 Austin Drive wanting to replace a 4 ft. fence with a 6 ft. fence on that property located outside of the desig-

nated zoning ordinance area. The Sidney Village Board of Trustees meeting was brought to adjournment at 8:40 p.m. following a motion from Trustee Jason Arrasmith and a second by Trustee Cyndi McCloud.
