The Sidney Village Board of Trustees met on Monday, November 6 in the Sidney Community Building meeting room at 7:00 p.m. Village of Sidney President Chuck White brought the meeting to order at 7:00 p.m. following the recitation of the pledge of allegiance by all in atten-

President White then asked for a motion to approve the minutes as written of the Monday, October 2 regular meeting of the board and of the Tuesday, October 26 board meeting regarding zoning. The minutes as written were approved following a motion from Trustee Leroy Schluter and a second to the motion by Trustee John Finn.

Village of Sidney President White next asked if there was any public comment and asked Sidney Improvement Group (SIG) President Mike Roy if he would like to lead off with announcements about SIG Hometown Christmas

Mr. Roy reported that free carriage rides will be offered in downtown Sidney from 6:00 – 9:00 p.m. on Friday, December 1. Carriage rides will depart from in front of the Sidney Community Library. The Sidney Community Library will be open that evening as well as the Sidney American Legion Post 433 at which free will donation chili will be served.

The SIG are sponsoring a Breakfast with Santa at the Sidney United Church from Finn seconded by Trustee

December 2 and a shop at home at Unity East Elementary from 10:00 a.m. - 3:00 p.m. on Saturday, December 9 so as not to be in conflict with an event taking place in Homer on December 2.

A Sidney resident was in attendance at the meeting to ask if the Village of Sidney parking ordinance applies to flat beds and/or trailers and was told that the ordinance covers parking for cars and

An outside of village limits Village of Sidney water customer inquired as to what their water rate is as the pdf posted on the village website does not provide the outside of village water rate. Village of Sidney Clerk Carol Moore asked for the customer's phone number so that she could call the customer about

their water rate. Village of Sidney resident Mark Catron asked if a balance sheet of the village bills could be published at the village website. Board members decided to place the subject of the publication of a balance sheet of village bills on the village website on the Monday, December 4 Sidney Village Board of Trustees meeting agenda.

Village of Sidney President Chuck White asked if there were any additional public comment and, as there was none, proceeded with his comments by reporting that the Illinois Municipal League membership fee is \$250.00. A motion from Trustee John \$250.00 membership fee car-

It was reported that the Village of Sidney had received a Bicentennial Resolution from the State of Illinois asking the Village of Sidney to fly a special Bicentennial flag that the State of Illinois was sending to the village at no cost and to hold a 12:00 p.m. flag raising of the flag on Monday, December 4. Board members unanimously adopted the resolution and Village of Sidney President Chuck White and Village of Sidney Operations Manager and Water Superintendent Earl Bennett will raise the flag at 12:00 p.m. on Monday, December 4.

President White announced that the Illinois Municipal Handbook is available at a cost of \$45.00, reported that the village usually purchases one, and asked if trustees wanted to purchase one or more at a cost of \$45.00 each. Trustee Cyndi McCloud's motion seconded by Trustee John Finn for the Village of Sidney to purchase one handbook at a cost of \$45.00

Village of Sidney President Chuck White entertained conversation concerning the Sidney Scoop Facebook social media page and reported on posted comments stating that the Village of Sidney was not being open about village water rates and were having closed meetings, etc. to discuss village water rates.

President White reminded all in attendance that committee meetings do not have Sidney committee meetings always have been, that committee meetings can be held at any time of the day as they are only discussion and planning meetings at which no votes are taken, that voting only takes place at official Sidney Village Board of Trustees meetings that take place in the evening, and that the general public has always been invited to both committee meetings and monthly board meetings.

A lengthy discussion took place concerning the Facebook page and disrespectful comments that had been taken off of the page. Some in attendance at the meeting did not appreciate the way they felt they were being censored.

Board members told all in attendance that residents with questions about water bills should call Village of Sidney Clerk Carol Moore.

Board members also reiterated that the Sidney Scoop Facebook page is not a Village of Sidney sanctioned page official Village of Sidney news is at the village's official website http://villageofsidney. com/index.html at which one can find village trustees, employees, and Village President phone numbers along with meeting agendas, meeting minutes, and a pdf for the Public Water Supply Inventory and Assessment Report. Individuals can also download an application for water and can pay water bills on line at the website.

Discussion concerning the 2017/2018 Tax Levy was brought up under Sidney Village Attorney Marc Miller's comments and a motion from Trustee Jason Arrasmith seconded by Trustee John Finn to pass the Village of Sidney Tax Levy Ordinance 2017-06 for the 2017/2018 carried.

The Village of Sidney Board of Trustees decided to add discussion concerning hiring a consultant for the water plant and consideration of an ordinance authorizing execution of Cont. pg. 2

Meeting was called to order

Trustee Cole made a motion to approve the minutes of the October meeting. Second by Hall. Motion passed

Trustee Cole made a motion to approve the November bills and accept the September 2017 financial report. Second by Hall. Motion passed 5-0.

Trustee Zurich arrived

Trustee Cole read a concern raised by the Village Auditor with the Village of Broadlands present accounting system. The Illinois

comptroller will require all municipalities to move to an accrual accounting system by January 2018. Trustee Hall recommended having the Village Auditor attend the next meeting to address this change.

At the last meeting Mitch Bensyl stated a tree on Diller Street on city property needs to be removed. Mayor Block contacted Jason Smith who gave a price of \$400 to remove the tree. Motion by Trustee Nelk to approve this expense. Second by Propst. Motion carried 6-0.

Water: Trustee Zurich stated he accepted the resignation of Mr. Garrison has water meter reader. Anyone interested in being the Village water meter reader should contact Trustee Zurich or attend the next meeting. In the interim, Ron Gast Jr. has offered to fill this role. The board discussed the present salary for the Village water meter reader. Discussion to continue to next meeting. Ron Gast has been working on the replacement of water meters. He stated there have been issues with a few of the newly purchased meters. He contacted DJ Stewart to reset Trustee Cole stated that
