SHERRY GUNTER, 36, was charged with vandalism after \$4,000 worth of damage was done to a structure on Neal Drive. Officers found Gunter still inside the residence when they arrived.

JOSE B. SOTO, 30, was charged with assault af-

ter a man reported opening his door and being punched in the nose. He told officers Soto was the man who assaulted him.

JULIAN G. SOTO, 37, was charged with second offense DUI after a deputy noticed he wasn't keeping to his lane of travel. Upon pulling him over, the officer noticed an odor of alcohol and other tell-tale signs of intoxication. He did poorly on his field sobriety test and was arrested.



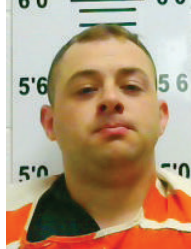

Grants used to help attract tourists

In her report to the county commission this past week, Chamber of Commerce Director Suzanne Williams revealed improvements being made to historic downtown Smithville as well as outreach efforts being undertaken in hopes of bringing even more tourists to DeKalb County.

"Due to our most recent Community Development Block Grant awarded to the Chamber in the amount of \$100,000 many façade improvements have been made to our downtown," she told commissioners in her report. "We have several new businesses in downtown Smithville including Old Timers' Antique Mall, The Vintage Owl, The Market on Main, and D & D Fashions. Two of our downtown businesses have outgrown their present space and are moving to larger buildings on the square."

Another grant, she said, will help with outreach. "The Chamber was awarded a new TN Department of Tourist Development Grant to be used for a Smithville Fiddlers' Jamboree billboard on I-40 reaching 42,000 cars per day."

The news got even better when she noted Smithville will be in the new Tennessee Music Pathway.

The Tennessee Department of Tourist Development has a new initiative, The Tennessee Music Pathway," she revealed. "The Smithville Fiddlers' Jamboree and Crafts Festival has been included on Phase 1 of this project. The music trail will be a 1,200-mile loop running the length of the state with a focus on preserving and promoting the history locally and how it has impacted music around the world and on current music events. The live venues where people can go and hear music will be an integral part of this. Being a part of this initiative will provide a lot of free promotion for our area."

She added the state economic development agency has also selected DeKalb County to be included in their best practices.

"DeKalb County and

Saint Thomas DeKalb Hospital will be featured as a 'Best Practices' in community partnerships and health initiatives for rural communities," she said. "This honor was given due to the success of the DeKalb County Health Adventure that was started by Saint Thomas DeKalb Community Benefit Dollars and continued with last year's Three Star Grant written and submitted by the Chamber and the County Mayor's office."

She added that DeKalb

County was also mentioned by the governor's office due to the county's increase in tourism dollars by 6.7 percent which was third highest in the Upper Cumberland region.

"So, DeKalb's tourism dollars provide \$6,330,000 from travel-related local tax receipts for our county budget," she reported. "That also means that the tax revenue from tourism dollars saves each household in DeKalb County \$955 annually."

City sets 20 mph subdivision speed limit

Motorists better get the lead out when they're motoring through subdivisions in Smithville as many will now have a maximum speed limit of 20 miles per hour.

The Smithville city board of mayor and aldermen voted to make subdivisions that do not already have posted speed limits have a speed limit of 20

miles per hour after several complaints by residents of the subdivisions.

City Police Chief Mark Collins told the board at the their last regular meeting that he would recommend the speed limit for Greenwood Drive, noting motorists who travel over 30 through the residential section are still going too fast given the area.

The board's ratification of the chief's suggestion will cost about \$1,000 for speed limit signs and will affect around four subdivisions.

State and Federal General Election

November 6, 2018

The DeKalb County Election Commission will conduct *Early Voting* for any eligible voter to cast a ballot by personal appearance at the DeKalb County Courthouse, located at 1 Public Square, Smithville, TN during the following dates and times:

October 17 through November 1

Hours: Mondays 1 p.m. to 5 p.m.; Tuesdays, Wednesdays and Fridays 9 a.m. to 1 p.m.; Thursdays 2 p.m. to 6 p.m.; and Saturdays 9 a.m. to Noon.

Registered voters who will be unable to go to their polling place on Election Day may vote one of the following methods:

- Voting by Personal Appearance**—Beginning October 17, 2018 through November 1, 2018, a voter desiring to vote by personal appearance shall go to the DeKalb County Courthouse, first floor, sign an application to vote and cast their vote on a voting machine. The last day to vote by personal appearance during the early voting period is November 1, 2018.
- Voting by mail**—A voter must meet certain legal qualifications to vote absentee by mail. A voter desiring to vote absentee by mail shall, in writing over his/her signature either in person at the Election Office or by mail, request an absentee application for an absentee ballot. The voter must make the request in writing and include their name (as registered), social security number, residential address (911 address), mailing address (if different), the election they wish to vote in, the reason they are requesting to vote an absentee ballot and their signature. **The written request must be received no later than October 30, 2018.**

PHOTO I.D. REQUIREMENTS: State law requires voters who vote by personal appearance to present a Tennessee or U.S. Government-issued photo ID. For more information regarding exemptions and acceptable forms of photo IDs, please contact our office or visit <https://sos.tn.gov/elections>.

What not to wear
State law requires polling locations and the area within a 100-foot boundary surrounding each entrance remain campaign-free zones. Tennessee law prohibits the display or distribution of campaign materials and the solicitation of votes for or against any person, party or question on the ballot in these areas.

Voters who have difficulty standing in line
Frail, physically disabled or visibly pregnant voters should tell their polling officials if they are unable to wait in line to vote. The law allows them to move through the process faster.

CELL PHONES: Under state law, you may use a mobile electronic or communication device for information purposes to assist you in making election decisions at the polling place. You may not use a mobile electronic or communication device for telephone conversations, recording or taking photographs or videos while inside the polling place.

T.C.A. 2-7-118: No voter who is voting without assistance may remain in a voting machine or occupy a voting compartment for more than five (5) minutes if other voters are waiting or more than ten (10) minutes in any event.
