A man faces assault charges after he slugged an officer who was trying to arrest him for running from the law days before.

The suspect, David Wayne Kirby 48, of Walling is charged with evading arrest, resisting stop, criminal impersonation and assault. He is due in court Oct. 25 to answer to the allegations.

The assault on an officer came two days after Kirby ran

from lawmen who were trying to pull him over. Kirby ultimately crashed into a fence and was able to elude capture for two days until he was found in the Whorton Springs area. Officers
