

'Michelle' charged for evidence tampering, lying to deputy

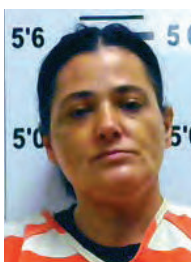

A woman who claimed her name was Michelle faces a host of charges after she tried to give lawmen the slip.

The woman, whose name wasn't really Michelle has been identified as Crystal Lashelle Thompson, 37 of Smithville. She stands charged with with criminal impersonation; resisting stop, frisk, halt, or arrest; and tampering with evidence. Her bond is \$23,000 and her court date is March 8.

According to Sheriff Patrick Ray, a deputy went to Restview Avenue to serve

warrants against her for failure to appear. Upon arrival, Thompson left through a back door and tried to flee on foot refusing the deputy's commands to stop.

"The officer caught up with her but while trying to place her in custody she ingested evidence, a hydrocodone pill," the sheriff said, noting she admitted to swallowing the hydro when confronted about what she had placed in her mouth.

However, she was less than cooperative about her real name, repeatedly telling the deputy her name was Michelle. Her claim was proven to be a lie when the officer checked on

her real identity, finding she was, in fact, wanted on outstanding warrants.

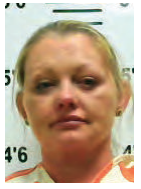
A mother caught drunk driving with her 3-year-old child in the car has been charged with reckless endangerment.

April Lynn Anderson, 34, of Tobbit Road in Warren County is charged with driving under the influence and reckless endangerment. Her bond has been set at \$6,500 and her court date is March 8. According to Sheriff Patrick Ray, a deputy responded to a stranded motorist call and found the vehicle on East Broad Street in Smithville.

"He stopped and spoke with the driver," Ray revealed. "Her three-year-old daughter was in the back seat."

The deputy noticed that Anderson's speech was slurred and that her eyes were red and watery.

"Anderson admitted to the officer that she had taken some medication earlier in the day," Patrick said, noting she submitted to field sobriety tasks but did poorly and was arrested.

Green gets two years for fleeing wreck scene

A Sparta man has been given two years in prison after he left the scene of a two-vehicle crash this past September.

The driver Robin Clark Green, 44, entered a plea by information to the charge of reckless endangerment. He was given a two-year sentence.

The wreck that landed Green in jail happened on Sparta Highway near Howard Redmon Road. He was going east in his 1994 Nissan Xterra when he crossed into the westbound lane to pass another vehicle on a double yellow line.

Juan Delgado of Smithville, who was traveling west on Sparta Highway in a

1998 Toyota Tacoma, swerved to avoid a collision but Green's vehicle still slammed into the Tacoma. Delgado's truck left roadway and struck a ditch. Green's vehicle went off the left side of the roadway and struck a ditch and a fence

Green fled the scene on foot. He had three passengers in the vehicle with him, 39-year-old Angela Atnip, 22-year-old Zachary Walker, and 42-year-old Barry Atnip all of Smithville. Both Angela and Barry Atnip were transported by ground ambulance to St. Thomas DeKalb Hospital while Walker was airlifted to Erlanger Hospital in Chat-

tanooga. Delgado was not injured but he was cited for not having a driver license and failing to provide proof of financial responsibility.
