AMANDA NICHOLE SMITH, 38, of Lebanon was arrested for public intoxication. Police responded to 625 Highland Ave for a disturbance call. Upon arrival officers made contact with Smith who appeared to be disoriented and became belligerent towards the officers. She didn't know where she was and saw a subject walking while the officers were present but the subject was not seen by the officers. Upon questioning, it was determined that Smith had a RX for suboxone and had taken it twice on this date. Due to her condition she was taken into custody for her own safety.
