Stribling wins by seven votes

It came down to seven votes, the incument County Mayor Tim Stribling defeating his predecessor Mike Foster by a count of 1,066 to 1,059.

The razor-thin margin left Stribling with a chance in August to retain his office.

Meanwhile, Nicole Wright will

get a chance to win the office she works in as she defeated Mark Milam for the Democratic nomination for circuit court clerk by a count of 1,203 to 1.023. The position has been held by Katherine Pack since 2002. Pack is not seeking re-election to a fifth term. Wright works for Pack in the Circuit Court Clerk office. Milam has served as Constable of the fifth district for over 25 years. Wright will face Republican Susan Martin

in the County General Election on August 2.

Sheriff's challenger Michael Agee advanced to August without opposition in the Democratic primary. Agee will face Republican Incumbent Sheriff Patrick Ray in the general election.

Jimmy Sprague was unopposed for the Democratic nomination for road supervisor. He will face Republican Danny Hale in August. County Court Clerk James L. (Jimmy) Poss, Trustee Sean Driver and Register of Deeds Jeff McMillen got an election cycle off and will be unopposed in August.

For the 14 county commission seats up for election this year:

In the first district, incumbent Julie Young and Dennis Slager both moved on without opposition in the primary. They will face Republican Tom Chandler in August, with the two top vote getters winning office.

In the second district, incumbent Joe Johnson will not get a chance for reelection as he was defeated by Nora Harvey and Myron Rhody in the primary, Harvey getting 147, Rhody 168 and Johnson 139. They will advance to take on Republican Sabrina Farler in August with the top two winning office.

Day of Prayer Thursday at courthouse

The community will join the rest of the nation Thursday in pausing at noon for a time of prayer.

The National Day of Prayer will be observed Thursday, May 3 in America. Smithville will observe this day at noon on the east side of the Dekalb County Courthouse (out on the lawn). The rain location is in the basement of the DeKalb County Courthouse.

"All are invited to join for a time of prayer for our nation, state and city led by local ministers from Smithville and the surrounding areas," said event coordinator Issac Gray. "It's time for God's people to come together and seek His face; we have a chance to do that on the National Day of Prayer."

A national day of prayer was first called for by the first Continental Congress in 1775 and was first established by President Abraham Lincoln in 1863. In 1952, Congress unanimously voted to establish a National Day of Prayer. The day was made official when President Harry S. Truman signed it into law. The annual observance is held on the first Thursday of

May and is designated by the United States Congress as a time when people are asked "to turn to God in prayer and meditation." Each year since its inception, the president has signed a proclamation, encouraging all Americans to pray on this day.

The constitutionality of the National Day of Prayer was unsuccessfully challenged in court by the Freedom From Religion Foundation after their first attempt was unanimously dismissed by a federal appel-
