

# CITY CRIME REPORT

## SHARP DRESSED MAN

James Dillon Matthews, 23, of Sparta was cited for theft of merchandise. A Wal-Mart employee observed Matthews open a pack of Gillette razors and put them into his pants.

## HALFWAY THERE

Makenzi Rene Creasy, 25, of Hohenwald was arrested for disorderly conduct. Police responded to 398 East Main St in reference to a disorderly person. Officers made contact with Creasy who was acting belligerent towards officers and had been yelling at the staff of the halfway house and even put her hands on one of her roommates when they were walking through the room. 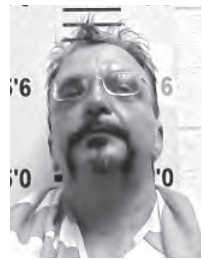
**SAMMY GENE TAYLOR, 57**, of Dowelltown was charged with domestic assault and will appear in court on June 14.
