A woman who went on a spending spree with someone else's credit card, even making a bail bond, has been granted probation but has been ordered to pay back the money.

The woman, Robin Lynn Woodard, 33, of Gordonsville entered guilty pleas in circuit court to charges of theft and fraudulent use of a credit card. She was given a total of three years but she will be allowed to be free on probation during her term. She will be required to make restitution of \$4,430

to one of her victims in the case of a residential burglary and \$1,509 to the other victim for using their credit card. She was directed to serve 30 days on a separate count of simple possession of methamphetamine.

According to Sheriff Patrick Ray, Woodard used a credit card that did not belong to her to purchase air time on a phone card on several occasions last October and then used it to buy items from PayPal. The sheriff said she even used it to pay a bail bonding agency, spending \$100 with Grumpy's Bail Bonds.

The second case Woodard was sentenced on concerned her breaking into a residence and taking numerous items including guns, a cross bow, camera, television, quilts, sheets and video game.
