Street dancer arrested

Police saved a man from being run over as he was dancing in the street, later charging him with disorderly conduct for his hazardous selection of dance floors.

The man, Nathan Joseph Wilbert, 38, is charged with disorderly conduct and resisting stop.

The incident began when Smithville police started receiving calls about a man dancing in the road and yelling at passing cars on West Broad Street. "He was angry and belligerent and throwing his arms up in the air," the police report reads.

Officers tried to get him out of traffic but saw a sharp black object in his hands. "He was instructed multiple times to drop the

object," the report reads. "He then clinched the metal object in his hand, held it like a knife and started yelling more."

Police tried to taze Wilbert but missed. He then ran into traffic. "One of the officers grabbed him by his waist to protect him from getting hit by an oncoming car and both fell to the ground," the report revealed.

Wilbert was taken into custody and it was discovered the object he had been clutching was a metal paint scraper. The police offi-

cer who saved him from getting hit suffered abrasions to his knee.

Mayor Poss had already been censured by the city's board of aldermen for his handling of the hiring of his son, which he did without board approval. Anthony Poss was reportedly hired by his father to maintain the golf course and country club facilities owned by the city. However, members of the city board confronted the mayor, some noting there was no proof Anthony worked the hours for which he was paid. Others pointed out RiverWatch had been

hired to do the same thing

Anthony Poss was reportedly hired to do, making the hiring a duplication of services.

Mayor Poss did not show up for special meetings called by the city board, during which they ultimately decided to publicly reprimand him, stopping short of filing suit for repayment of the city money paid to Anthony Poss between August 2017 through 2018. The mayor did send a prepared statement to the board the night of the censure.

"I want the council and the public to understand that my only goal was to safeguard and maintain the equipment located at the golf course," he said in his prepared statement. "I want to assure you that it wasn't a waste of the city's funds because the equipment must be maintained and my son was the most logical choice. In hindsight, his hiring without council approving may have been a mistake.

The total amount he earned was \$8,100.

The pair are set to appear for arraignment on Aug. 6. Mayor Poss is presently in the middle of a campaign for reelection.


