"The pathologist comes in, sits down and looks at me," said Williams. "The atmosphere in the room just got darker for me. He savs 'Mrs. Williams, I don't know how to tell you this, but there is not one good thing about your mammogram.' He said on a scale of 1 to 10, and 10 being the most abnormal with the most abnormalities, I was a 10. The whole top part of my chest down to the nipple and out to the side is covered. I knew I had cancer. He didn't have to say it." subsequent biopsy А revealed it was stage three and stage four, triple negative breast cancer. Triple negative means the tumor is estrogen receptor-negative, progesterone receptor-negative, and HER2-negative. The finding came Dec. 21, one day prior to her 28th wedding anniversary. She was scheduled for 16 rounds of chemotherapy at Vanderbilt Medical Center. Her 11th chemo treatment was May 29.

is responding at this time. Once the chemo treatments have been completed, they'll do another mammogram or a body scan. We are hoping it's gone. Somedays it feels the exact same and just as big as it was. Some days it feels flat and spread out. We don't know what it's doing right now."

The results of those follow-up tests will determine future treatment, such as a mastectomy. For now, Williams focus-

es on her blessings.

"There have been more blessings than I can count. Warren County has been so good to me. I've met people encouraging them? No, I didn't. I will now, because I know how meaningful it is to someone who's struggling. Just when I'm trying to figure out how I'm going to make it through this day, I'll receive a card in the mail from someone telling me I can beat this. The cards I've received have meant so much to me."

Williams credits Jessica Higgins, an LPN with St. Thomas Medical Partners, for her quick medical treatment.

"Jessica had a terrible time working with my insurance and trying to get me into a mammogram and get treatments started quickly, but she never gave up. It was like I was her mom. I'll never forget how hard she worked for me. I've got her cell number in my phone. It isn't under 'Jessica.' It's under 'Angel' because that's what she is to me. She's my angel. Hopefully, every cancer patient has an angel like Jessica working for them." Higgins refuses to take credit.

the phone and I try to treat everyone the way I would want my mom or family member treated. Detra Whiles, our practice coordinator, was there with me that day and she was very helpful in getting Tammy the care she needed."

who I probably wouldn't have met. I'm bald and people have walked up to me and said, 'I've had cancer too. I'm a survivor.' People hug me. Hugs are wonderful. I've had so many people reach out to me. Almost daily, I get a card in the mail from someone encouraging me to stay strong and telling me I can beat this."

She adds, "This experience has changed me. I've heard about people in the community with cancer. Did I think about them? Yes. Did I take that extra step to send them a card in the mail

"I'm honored she thinks highly of me," said Higgins. "I was just doing my job. I could tell she was upset on she said. "Relay should be a celebration of life. It's an uplifting time for survivors. I've asked myself over and over, 'I'm a survivor?' I think I am. I'm fighting this and I'll continue to fight. I have two daughters. One is 20 and one is 26. I want to see them get married. I want to live to see my grandchildren."

Williams told her story with two goals in mind: 1) to encourage women to get mammograms; 2) to let nurses know how important they are in the lives of their patients.
