## Teacher handcuffed, removed for comments during meeting

**NEW ORLEANS (AP)** — A Louisiana teacher was removed from a school board meeting, forcibly handcuffed, and jailed after questioning pay policies during a public comment period.

The teacher's union and the ACLU are investigating and two board members are complaining that the board treats women unfairly.

A video posted by KATC-TV shows middle school English teacher Deyshia Hargrave complying with a city marshal's orders to leave Monday night's Vermilion Parish School Board meeting. Next, she is seen on the hallway floor, screaming as the marshal handcuffs her behind her back.

"Stop resisting," the marshal says, hustling Hargrave toward an exit after lifting her to her feet.

"I am not. You just pushed me to the floor," Hargrave responds.

officer, according to KATC. The station reported that board president Anthony

Fontana had ruled Hargrave out of order for asking questions during a time reserved for public comment. Later in the same meeting, she spoke again in response to a question from the board, and was confronted by the marshal despite objections from the audience. "She was recognized!" several people said.

"This is the most disgraceful and distasteful thing I have ever seen," another audience member said

as Hargrave made her way out. Women have several times been told to leave meetings, while men who speak out have not been removed,


Abbeville jail on charges of "remaining board member Laura LeBeouf told The view Tuesday.

"When she realized she had to get out, she picked up her purse and walked out," LeBeouf said. "Women in this parish are not getting the same treatment."

The board's other female member expressed similar sentiments.

Longstanding divisions on the eight-member school board preceded the meeting, according to LeBeouf and board member Kibbie

Pillette, both of whom said that a new contract for the school superintendent gives him the opportunity to earn as much as \$38,000 more per year, while the board hasn't raised teacher salaries in more than a decade.

After a nearly three-year wait, a sidewalk on Sparta Street could materialize in 2018.

City administrator Bill Brock says he's contacted James C. Hailey & Company, consulting engineers, and bids could go out this spring.

"I spoke with Matthew Tucker with James C. Hailey and they're about 70 to 75 percent done with the drawings on that par-ticular site," Brock said. "The state has been working with them real well on getting some things turned around. We had to get some more engineering done and a survey done and get that back to them. He told me we are looking at going out for bids in the spring. Hopefully, we can get it bid out and get it

#### started."

The city of McMinnville was awarded a \$948,080 Multimodal Access Grant from TDOT in June 2015 for a sidewalk along Sparta Street. The grant slowly spun its wheels in state government, including two trips through the environmental evaluation stage.

Making the grant worth the wait is the fact it will fund 95 percent of the project, with only 5 percent funded with local matching dollars. Total project cost is approximately \$1 million.

The 95 percent is reimbursable, meaning the city must fund the project, then be repaid by the state. However, no work can begin until the state gives its approval or the grant will be lost.

Until bids are received, the actual cost of the sidewalk is unknown.
