To participate in the Tennessee Agricultural David Kirkpatrick, Beef Enhancement Program at the 50 percent reimbursement level, you must have a current Beef Quality Assurance certification administered through the Tennessee Cattlemen's Association with the educational component conducted by the University of Tennessee Extension.

This is a program of the Tennessee Cattlemen's Association. Costs of BQA certification is \$20 for TCA members and \$40 for non-members.

All fees are paid directly to the Tennessee Cattlemen's Association. The upcoming class is

for producers whom have never attended an Advanced Master Beef course or attended an AMBP course prior to 2015.

Producers who attended an Advanced Master Beef certification prior to 2015 will not qualify for the 50 percent TAEP cost share for the 2018 program year. If you have any questions, please contact UT-TSU Extension Warren County and we will check the database for you and let you know when your certification is expiring

To register, you must come by the UT-TSU Extension office located at 201 Locust Street, Suite 10 McMinnville.

Cost for the course is \$75, which covers all materials, refreshments, and a cap and farm sign for all graduates.

Skylar Alford was asked to write a letter to someone she was thankful for.



students with great test scores. I believe it is part of a school counselor's responsibility to ensure all parties involved in a student's life remember that behind each score is a human being ... a child that sometimes needs someone to care before he or she cares."
