
## **Rolling good time**

## Helpers needed for cleaning new trail

Volunteers are needed to work on a new river trail.

Helpers will meet at Rocket Park on Saturday, March 3 at 9 a.m. near the River Watch entrance to the trail.

The work will take approximately three hours.

Individuals are asked to bring chainsaws, hand saws, loppers and trimmers to cut privet bushes and multi-flora roses from the wooded areas

along the trail. "Some people are need-

ed to drag the cut brush into stacks for city employees to remove," said Wally Bigbee, who coordinates the effort. "Some adults are needed to paint the cut stumps with herbicide. One damaged tree needs to be cut down and cut into moveable pieces. Bring your own tools or

use ours." Runoff water has cut a small gulley across a section of trail. Bigbee says areas need to be fixed.

"A diversion ditch needs to be cut for it. Drainage rock should be placed on the trail gulley. We need mattocks, spades, shovels, and wheelbarrows.'

Everyone should bring gloves, water and snacks.

The city of McMinnville requires signing a waiver of liability for adults and signing of a responsible party for non-adults.
