Hennessee says renovating the sidewalks on West Main and Sparta streets are under consideration, but he would like the utility pole situation resolved first.

"Sparta Street doesn't have the issues of the utility poles but West does," said Main Hennessee. "We would rather do it block to block length. If the poles get moved later, vou might have to change what you just repaired. We could schedule sidewalk repair on a much more frequent basis if we had the utility pole issue resolved. We could go in and identify the sections of sidewalks that need to be torn out or repaired and brought into compli-

Along with creating a stumbling block for the city to become ADA

compliant by December 2019 deadline given by the state, at least one pole is creating a traffic hazard.

"I think the most ludicrous one is on the corner of Lind of West Main," said Alderman Everett Brock of a pole owned by Frontier Communication. "Someone hit that thing and torn the pole down back about eight or nine months ago. That pole sat about 2 inches off the road. When they put the new one in, it literally is right on the road. If you have three lanes of traffic, you can't get by there. I've sat there and stopped in the road because there's not enough room if someone is in that turning lane."
