

## NOTICE TO TAXPAYERS

**Tax Relief:** The State of Tennessee has a tax relief program. You may qualify if your Warren County home is your primary residence and you provide proof of the following requirements:

**Elderly:** Age 65 or older as of December 31, 2017 and your total income of all persons on the deed plus spousal income whether on the deed or not, did not exceed \$29,180;

**Disabled:** If you are 100% totally and permanently diabled as rated by the Social Security Administration or other qualifying agency on or before December 31, 2017 and your total income of all persons on the deed plus spousal income whether on the deed or not, did not exceed \$29,180;

**Disabled Veteran, totally or permanently disabled veterans/surviving spouse of disabled veteran:** Determination of eligibility will be made based on information provided by the VA through use of consent forms for a Disabled Veteran or widower of a Disabled Veteran available at the Trustee's office

If you feel that you may qualify for this program, please come by my office or give us a call.

The last day to sign up for 2017 tax relief is April 5, 2018.
