"This is the story everyone is enchanted by," said seasoned director Logan Taylor. "It has tons of singing, the music is great, and the costumes and set are incredible. We have 75 kids in the show, which is our biggest performance thus far."

It's the second leading role for Saylor, who wowed the audience with her performance as Jane in "Tarzan."

"Playing Belle is different," said Saylor. "She's so patient and so kind. I don't have nearly that much patience."

It will be the 28th production for Brady, including three at Park Theater. He says this is his most challenging role.

"The character is so complex," said Brady. "He goes from prince to beast, from man to monster, and I have to sing as both characters."

order to break the spell.

That sets up the relationship between Belle and the Beast, although their potential romance has its share of roadblocks. Gaston is one of the obstacles as the lovely Belle has caught his fancy and he proposes to her. Despite Belle's polite rejection,

Gaston is determined to win her hand, setting up a climatic duel with the Beast for her affection.

Thanks to the popularity of Dream Reality Group's previous shows at Park Theater, "Beauty and the Beast" has sold out its four shows this Thursday, Friday

# Add smoke detector checks to your spring cleaning list

We've sprung forward. Now it's time to test smoke detector batteries.

The time change is a good reminder to check, and if needed, replace smoke detector batteries.

According to the National Fire Protection Association, almost two-thirds of home fire deaths resulted from fires in properties without working smoke alarms. A working smoke alarm significantly increases your chances of surviving a home fire.

McMinnville Fire Department Chief Kendall Mayfield said free smoke alarms are still available.

"We went out with the American Red Cross to put up smoke alarms in the Bybee Branch area," said Mayfield. "We placed over 60 smoke alarms in those apartments in that area to help the Red Cross. We also set up at the Home Show and had people come by to sign up for a free smoke alarm. We're going to be busy for the next month or two putting

them in."

The department entered into a partnership with the State Fire Marshal's Office in March 2013 as part of a statewide distribution of smoke alarms in an effort to both educate and equip Tennesseans to incorporate fire safety into their daily lives. Since that time, more than 1,000 smoke detectors have been received and installed by the department.

The program has a few restrictions: 1) The owner of the property must sign giving permission for the installation; 2) The city fire department is restricted to homes located within the city limits; 3) Smoke detectors are limited to three per household and are

available on a first-come, first-serve basis.

Warren County residents who do not live within the city limits can apply for a free smoke detector through the Warren County Emergency Management Association. The city department established a partnership with EMA director Jim Cunningham in 2015 to make the devices available to all Warren County residents.

FEMA grant funds were used to purchase the smoke detectors, which utilize a lithium

battery with a 10-year lifespan.

For homes with smoke alarms without the long-life lithium battery, be sure to test the device at least twice a year. Daylight Saving Time, beginning and ending, can be used as a reminder. If the alarm chirps, replace only the battery. Date each unit when they are installed and replace them after 10 years – or sooner if they do not success-

fully pass the test by sounding the alarm when the test button is pressed.


