With the game-winning run standing 90 feet away, Smith came through to give the Pioneers their fourth win, and second in a row after snapping a fivegame losing streak last Friday with a victory over Tullahoma. The sudden blowout gave the Pioneers some momentum, but coach Powers believes his squad can still can grow from the win.

"The scoreboard was a little deceiving. I didn't think we were too sharp. We came out a little flat off of spring break," said Powers. "That's a positive takeaway – we didn't play well and still won.

"Baseball is a funny game. I think we've played better games and lost, and then sometimes you don't play great and win. Those things will happen. We can still play better in all facets."

The Lady Pioneers rolled to their sixth straight victory Monday, dropping Tullahoma 20-1 on the road. During the winning steak, Warren County has now outscored its opponents 74-6.

Warren County (9-1) didn't seem slowed from having a week off for spring break. The Lady Pioneers scored 13 runs in the opening inning, and could've had more but coach Joe Damon had his team step off the bag early to end the onslaught.

The Lady Pioneers went on to add four more runs in the second, one in the third and two in the fourth before the game was stopped due to run rule.

Coach Damon was impressed at his team's level of play coming off the break, especially his team's hitting.

"The bats were still hot after a week off and the defense played well behind Danika (Reno)," said Damon. "The outfield – Mea Starkey, Shelby Roberts and Marli McBride – really shined. They limited girls to singles and showed off some speed and tracking ability."

Reno, who got the win by going all four innings, didn't have to worry about run support after the first frame. ishing with two hits. Madison Hollis had a single and a double, the former scoring the game's first run and the latter making it 8-0 when McBride and Starkey were able to score following their own hits.

Halo Armstrong added two RBI singles in the opening inning, with her second making it 10-0. Roberts, Juju Pyburn and Aleya Esparza added early run-scoring singles, while McBride provided the exclamation point with a two-run triple to make it 13-0.

Tullahoma scored its lone run in the top of the inning, turning a lead-off single into a run on a groundout after two passed balls. Reno faced just 10 batters the rest of the way, surrendering only three hits to earn her fifth win.

Esparza and Reno provided the scoring boost in the second. Both drilled tworun doubles to left field, pushing the Lady Pioneers ahead 17-1.

Pyburn added another RBI double in the third, while McBride and Starkey added RBIs in the fourth.

McBride led the charge at the plate, getting three hits (two triples) and four RBIs. Hollis also had three hits and three RBIs. Roberts, Pyburn, Esparza, Armstrong and Reno all had two hits and RBIs. Bella Cantrell added a hit and a run.
