## Horsin' Around trail ride set for April 14

You won't have to hold your horses much longer because the third annual Horsin' Around is coming April 14.

Horsin' Around is a fundraising trail ride benefiting the equestrian program for men, women and children with special needs.

Registration will begin at 9 a.m. at Horsin' Around Farm, 386 Viola Road in McMinnville. The ride is \$25. For those who want to participate but not ride, the cost is \$10. For children 10 and under, the cost is \$5. The price includes lunch, entertainment and activities.

Recent questions surrounding the zoning of 386 Viola Road will not have an impact on this year's event.

"I'm on the horse side of things so I'll be the one leading the ride up to the top of Ben Lomand Mountain, which usually takes 2 to 3 hours," says Neal Cox. "The horse riding mini-lessons are also really popular as everyone loves to ride Prince the Pony."

Through a Rotary grant, the program started with the basic purchases of special saddles, helmets, stirrups, and other items. When storage became an issue, another Rotary grant aided in purchasing a box trailer. This year's proceeds will go toward finishing the tack building, which will provide a bathroom for the children and more equestrian supplies.

"It's very important to us to keep this equestrian program alive," says Holly McBride, one of the event coordinators. "The benefits are scientifically proven and I've seen a child with non-verbal autism speak on a horse so that immediately won me over."

There is something for everybody this year including a petting zoo, pony rides and carnival games. These fun activities will begin at 10 a.m. and continue throughout the event. Lunch will be served at 12:30 p.m. followed by a live auction.

Judge Bill Locke ruled on the following cases Tuesday in General Sessions Court.
