
# **Brock seeks First District County Commission seat**

"We've hosted the river cleanup for 10 years," said Killebrew. "There's been over 300 tons of garbage removed over those 10 years so we wanted to add some new things based on what we've learned. The Adopt-A-Mile is in addition to our river cleanup. We're continuing the annual cleanup."

Similar to Adopt-A-Mile programs for highways, the river adoption seeks to get the community more involved in keeping the rivers clean by allowing people to adopt a section they can then care for as a project.

St. Matthew's Episcopal Church, the Methodist Church, Kids of the Community, McMinnville Water Department, and Warren County Utility District have expressed interest in adopting miles.

Tennessee Wildlife Resources Agency is currently generating river maps that can be used to designate any adopted miles. Measures are underway to help people find their section of river, including GPS coordinates and signage.

Breakfast Rotary aims to have a booth set up at Three Star Mall in the next month so people can stop by, look at the maps, and select their sections.

Tate, his brother Dakota, and Talley climbed into his Chevy Z71 pickup. The crash occurred when Tate failed to navigate a curve on Spencer Highway (Highway 30) near the Shellsford Road intersection.

His pickup hit several trees before flipping. None of the occupants were wearing seatbelts. While the Tate brothers were likely saved by deployment of their front-seat airbags, Talley was in the backseat and was ejected.

Tate was later given an eight-year sentence, served one year, and is currently on

## probation.

He was ordered to pay \$3,000 in court costs and fines, as well as perform 100 hours of community service.

In the United States, 1-in-3 women and 1-in-6 men experience some form of contact sexual violence in their lifetime.

Families in Crisis is raising awareness with a free showing of

"Audrie & Daisy" at Park Theater on April 12 at 6 p.m. for Sexual Assault Awareness Month.

"It is an urgent, real-life drama that examines the ripple effects **STUBBLEFIELD** families, on friends, schools and communities

when two underage young women find that sexual assault crimes against them have been caught on camera," said Kristy Stubblefield, executive director Families in Crisis.

"Audie & Daisy" takes a hard look at Ámerica's teens who are coming of age in this new world of social media bullying, spun wildly out of control.

During this time, Families in Crisis will also be displaying "What I was wearing when I was raped," a display of clothing that victims of sexual assault were wearing when they were sexually assaulted.

Stubblefield says the display is aimed to dispel a misconception clothing has something to do with sexual assault.

"This display asks participants to understand it was never about the clothing and the act of shedding those clothes is never enough to bring peace or comfort to survivors," she said. "The violation is not simply woven into the fabric of the material, it is a part of the survivor's new

narrative. If only ending sexual violence was as easy as changing our clothes. Instead it requires all of us to evaluate what enabled us as individuals and as a society to ask, 'What were you wearing?' in the first place, instead of 'What can we do to help?'" Families in Crisis works

decrease to barriers for victims of sexual violence in Warren County by offering free comprehensive services to victims of sexual violence.

"Victims of sexual violence living in rural counties have

"Opportunities for medical, legal or support services are scarce, or even non-existent."

Among the services Families in Crisis provides are 24-hour emergency shelter for victims fleeing a dangerous situation, hospital accompaniment, individual supportive counseling and support groups, and court advocacy.

Other statistics: rape is the most under-reported crime with 63 percent of sexual assaults not reported to police.

One-in-5 women and 1-in-71 men will be raped in their lives.

Fifty-one percent of female victims of rape reported being raped by an intimate partner and 40 percentby an acquaintance.
