Immigration raid nabs 97

eral immigration raid that took 97 people into custody at a Tennessee meat processing plant may be the biggest employment crackdown under President Donald Trump's administration, civil rights activists said Friday.

Eleven people were arrested on criminal charges and 86 were detained for being in the country illegally, U.S. Immigration and Customs

NASHVILLE (AP)—A fed- Enforcement spokeswoman Tammy Spicer said in a statement Friday.

The Thursday raid on Southeastern Provision, a meat processing plant in Bean Station in East Tennessee, is the largest single worksite immigration enforcement action since the administration of President George W. Bush, said Jessie Hahn, labor and employment policy attorney at the National Immigration Law

"This is part of the stepped-up Trump mass deportation enforcement agenda for sure," Hahn said.

The current administration has promised to crack down on employers who hire immigrants living in the country illegally, and several raids have taken place across the country.

A total of 21 people were arrested after immigration agents raided 7-11 stores nationwide in January.

Several children had both parents placed in detention and many did not show up for school Friday because of fear in the immigrant community, said Stephanie Teatro, co-executive director of the Tennessee Immigrant Refugee and Rights Coalition.

Many of the people employed at the plant had worked there for years and are long-standing members

TBI issued an Endangered Child Alert, and law enforcement agencies, search and rescue organizations, and citizen volunteers began an exhaustive search in the area of his residence.




