## Do Verizon, AT&T make it hard to switch?

opened an antitrust investigation into whether AT&T, Verizon and a standards-setting group worked together to stop consumers from easily switching wireless carri-

ers. companies confirmed the inquiry in separate statements late Friday in response to a report in

The New York Times. The U.S. government is looking into whether AT&T, Verizon and telecommunications standards organization GSMA worked together to suppress a technology that lets people remotely switch wireless companies without having to insert a new SIM card into their phones.

The Times, citing six anonymous people familiar with the inquiry, reported that investigation

complaints. Verizon, which is based in New York, derided the accusations on the issue as "much ado about nothing" in its statement. It framed its efforts as part of attempt to "provide a better experience

The company said it "will continue to work proactively within GSMA, including with those who might disagree with the proposed standards, to

move this issue forward." GMSA and the Justice Department declined to comment.

> PHOENIX (AP) — U.S. health officials on Friday told consumers to throw away any store-bought romaine lettuce they have in their kitchens and warned

restaurants not to serve it

amid an E. coli outbreak come from the city of Yuma. 50 people in several states.

The U.S. Centers for Disease Control and Prevention expanded its warning about tainted romaine from Arizona, saying information from new illnesses led it to caution against eating any forms of the lettuce that may have origin of the contaminated vegetables.

Previously, CDC officials had only warned against chopped romaine by itself or as part of salads and salad mixes. But they are now extending the risk to heads or hearts of romaine lettuce.
