Dean says the state's last governors, Phil Bredesen and Bill Haslam, have made education a focal point and the results apparent. More Tennesseans than ever are earning college degrees and better-paying jobs are locating here as a result.

Many Tennesseans list healthcare as their chief concern, according to Dean. He had visited 94 of the state's 95 counties as of Monday night and said he would be visiting the 95th county shortly.

"If you're in a part of the state where there's been a hospital to close, that's a big issue," said Dean referring to 10 rural hospitals to close in recent years. "The opioid crisis, if you want to combine that with healthcare, that's a big issue."

When asked if some of those 10 rural hospitals could have been saved if Tennessee were to opt into the Affordable Care Act,

Dean said, "Medicaid expansion would make a difference. Tennessee still needs our fair share when it comes to healthcare dollars. It certainly exacerbates the situation when you take away those dollars. It's a complicated issue, especially surrounding rural medicine."

When asked about enacting gun control as a way to slow the mass shootings we're seeing in Tennessee and throughout the nation, Dean started by stressing he's a firm supporter of the Second Amendment. However, he admitted the shootings are occurring with alarming regularity and suggested some government action.

"Nothing is going to happen unless we have a common agreement and I think an area where most people can agree is that we don't need people who are mentally unstable running around with guns," said Dean in promoting a need for greater background

Seals faces charges of theft and exploitation of an elder

A local woman faces two felony charges after reportedly stealing more than \$1,000 in antiques and trying to resell the items falsely claiming the owner was dead.

Carolyn Denise Seals, 54, has been charged with financial exploitation of an elderly or vulnerable adult, a Class D felony.

She's also charged with

theft over \$1,000 but less than \$2,500, a Class E felo-Seals was indicted on both charges by the

Warren County grand jury earlier this month. According to the indictment, Seals wrongfully obtained the property


from a family member

without permission between the dates of Feb. 19 and Feb. 27 of this year. This included

antique furniture and glassware. She then tried to sell the antiques as her own, claiming the former owner deceased.

"The person is in fact very much alive," said District Attorney General Lisa Zavogiannis, who has worked to strengthen laws pertaining to abuse against the elderly.

Last year as chair of the Elder Abuse Committee for Tennessee District Attorneys, Zavogiannis worked to get legislation passed on the state level

those convicted of crimes against mentally challenged individuals or the elderly, defined as persons 70 and older. The crime is enhanced one class.

The result is a longer sentence. For example, a Class E

felony carries a 1 to 2 year sentence, while a Class D felony carries 2 to 4 years. The committee continued its work this year and got legislation passed to enhance fines for those who commit elder abuse.

That money is then put in a fund to help victims.

Zavogiannis worked to increase the punishment for the most serious elder abuse offense.

"If you neglect an elderly person to the point where they die, you can now be charged with felomurder," Zavogiannis. "Previously, the highest charge was second-degree murder."

NASHVILLE (AP) Republican Tennessee Gov. Bill Haslam says he's allowing legislation billed as a push against sanctuary cities to become law without his signature, saying it has stirred up irrational fear on both

Haslam told reporters Monday that Tennessee has no sanctuary cities and state law prohibits them. He said it's not a

mass deportation bill. Haslam said it's best for Tennessee to move on.

The legislation bars local "sanctuary" policies and threatens to withhold future state economic and communitv development money from those not comply-

Local governments would have to comply with federal immigration detainers of people identified as in the country illegally without requiring warrants or probable

NASHVILLE (AP) — In a blow to the owner of Opry Mills Mall, the Tennessee Supreme Court has let stand a lower ruling court's that stripped \$150 million of insurance coverage for the 2010 flood.

The state's highest court announced it would not hear an appeal from the Simon Property Group.

The mall was submerged in 10 feet of water during the flood that killed 10 people in Nashville. It took two years for the property to be rebuilt and cost millions of dollars.

A jury awarded the property group \$200 million from a group of insurers. But an appeals court said the company was only due \$50 million, which was the limit for properties listed in "high hazard flood zones."
