# **Pastor arrested for molestation**

Authorities say a pastor in Tennessee has been arrested after he was caught by deputies inappropriately touching a 12-year-old girl. WTVC-TV quotes Grundy County Sheriff Clint Shrum as saying William E. "Tim" Smith Jr. is charged with

sexual misconduct.

Smith's case was sent to the grand jury Tuesday. Shrum says the Palmer Church of God pastor was arrested after investigators found him and the girl in a remote wooded area in his truck. Shrum says the two were engaged in sexual conduct

been released. She says in the report Smith was supposed to be dropping her off at home when the assault happened.

The grand jury is set to meet July 9.

**LAFOLLETTE** (AP) — The vice mayor of a Tennessee city and two others have been charged in an alleged food stamp conspiracy.

The Knoxville News Sentinel reports a grand jury issued an 80-count indictment against LaFollette Vice Mayor Joseph David Bolinger, Jennifer Lynn Brown and Jimmie Ivey this week. The three were arrested Wednesday. Sixty-eightyear-old Bolinger, 34-yearold Brown and 62-year-old Ivey are each charged with fraudulent receipt of food assistance. Ivey also is charged with 70 counts of

theft less than \$1,000.

Campbell County Sheriff
Robbie Goins says Ivey
and Brown gave people
cash for items they had
bought with EBT cards at
their store, and then sold
the items for profit.
