

# Logan Taylor's debut film conveys message of hope

The Park Theater audience gave "Until the End" a standing ovation following its premiere Saturday night.

The 35-minute film was written and directed by McMinnville resident Logan Taylor and shot in Warren County. WCMS was a central filming location as the movie revolves around high school student Lila Baker, played by Lacy Hartselle.

"The one thing I hope this film conveys is you should never lose hope," said Hartselle while doing interviews from the red carpet. "My character goes through so many hardships. It's great to see she can persevere."

Oscar Mansky plays the part of Judah Rigsby, the popular kid in school from a well-respected, wealthy family. Judah is dating Lila, but his nasty demeanor makes it a relationship where Lila is miserable.

"I learned how to be bad from my brother," joked Oscar, who attended the red carpet ceremony with his brother Walter. "I think the overall message from this is you have to stick up for yourself."

Lila is engulfed in despair because of her unhappy relationship with Judah and because of her ruthless mother, Lorraine Baker, played by Robin Dyke.

Her mother wants nothing more than for Lila to marry into the esteemed Rigsby family, at one point telling Lila to "get on that Christmas card." Her mother is completely overbearing, forcing Lila to weigh herself every day and making snide comments when she gains a pound.

"Fat girls don't get the rich men Lila," her mother says. "That boy is your ticket to the good life."

Judah's rude behavior becomes criminal when he rapes Lila in the woods at a party. Lila is

still huddled on the ground after the rape when she's approached by Kyle McCoy, a loner who has been building a connection with her. Kyle is played by local resident Luke Nafrada.

As Lila and Kyle spend more time together, the relationship does not sit well with Lila's mother. She wants Lila to dump Kyle and find a way to get back together with Judah. She even has Kyle arrested.

Then comes the bombshell about Lila's pregnancy.

# Trump supporters say family separation issue 'blown out of proportion'

**DULUTH, MINNESOTA (AP)** — Big Lake, Minn., resident Pam Tolve believes President Trump was just doing his job when he decided to separate children from parents who crossed the border illegally.

Billy Inman of Woodstock, Ga., said he felt sorry for the children but their parents were responsible.

Diehard Trump supporters remained steadfast, even as heart-rending photos of children held in pens and audio of terrified children crying out for their parents stoked outrage among Democrats and Republicans alike. They believed Trump and Homeland Security Secretary Kirstjen Nielsen when they falsely claimed they had no choice but to enforce an existing law.

After Trump signed an executive order Wednesday to end forced separations — acknowledging he could act without Congress after all — they shrugged.

The end, they suggested, justified the means, and the separations were the fault of Congress and those crossing the border illegally.

"It's been blown out of proportion by

the Democrats and the left," said Tolve, who attended a Trump rally Wednesday in Duluth, Minn. "I think it's being handled appropriately and they are just seeing a different way to put a bad light on the president."

She and Inman, like many Trump supporters, blamed the separations on the border-crossers rather than the president.

"The mamas and daddies are responsible for that," said Inman, a 55-year-old truck driver. "I feel sorry for the kids ... but why can't we protect our borders the way other countries protect theirs?"

John Trandem, 42, who owns an automotive services company near Fargo, N.D., said he has supported all of Trump's decisions during the border controversy.

"Nobody wants to see parents and children separated, but ... the blame should be put squarely back on the shoulders of the people who broke the law in the first place," said Trandem, who was a delegate at the 2016 Republican convention where Trump clinched the nomination for president.

Officers asked for consent to search a truck in the driveway believed to belong to Elkins. He denied consent.

Elkins was transported to Warren County Jail. He made \$50,000 bond Wednesday and was released.
