The Monster Energy NASCAR Cup Series took the Father's Day weekend off, giving me a chance to discuss a problem, (as I see it), in NASCAR.

When a driver wins a race and then fails post-race inspections, his win is deemed encumbered. That means the win does not count for the playoffs. The win and the playoff points do not count in the standings. The team is fined, the crew chief is suspended for several races, but the money and trophy are given to the penalized driver. Why doesn't NASCAR just take away wins for failing postrace inspections?

The official line is that NASCAR doesn't want fans to leave the track having seen a race winner, only to get home and find out they didn't win after all. With today's technology, if the winning car failed post-race tech, fans would know by the time they got home, possibly before they left the parking lot. Most fans are knowledgeable enough to understand what happened and accept the penalty.

There's no reason to award a win to a car that's not legal after a race in this day and age, and it's high time NASCAR starts making sure the winner raced a car that's within the rules.

Flamethrower Taylor Smith propelled Gary Steele Karate to the tournament finals with a 5-2 victory over Beasley's Brawlers. Smith was lights out on the mound, throwing a no-hitter in the dominant performance. The Brawlers only had five batters reach base, all on walks – including Isaac Beasley and Brady Melton scoring on wild pitches after drawing free passes. Alex van Vuuren helped Gary Steele

Karate get off to a quick start, dropping in a two-run triple in the first inning. The Gary Steele slugger drilled a 1-2 pitch from Balor Melton to the fence, sending the Brawler outfield scrambling as van Vuuren put on the burners to reach third.

Melton, who had three strikeouts while taking the loss, was able to limit the damage to two runs with a strikeout, stranding van Vuuren at third.

Smith set the tone with the very first batter, humming in three straight strikes for his first of six strikeouts. Beasley was able to reach on a walk and steal around to third and score on a passed ball, but Smith followed with a strikeout and groundout to preserve a 2-1 lead.

Dominque Padin pushed the lead to three in the second, ripping a bases-loaded double to score Jax Patterson and Seth Cruze after both drew walks. Talan Mullican followed with a single to score Padin and make it 5-1.

Jared Scruggs entered in the second and shut down Gary Steele going forward, striking out seven of the 10 batters he faced. It was too late though.

Smith continued to rip through the Brawlers, keeping batter off balance with his speed and imposing curveball.

Beasley's had one final chance to cut into the lead in the fourth, getting Melton on with a lead-off walk before moving over on a Kadin Tackett groundout. Melton

The current system isn't really looking to punish the teams that overstep the boundaries. Instead, it's catering to the organizations with the most money and the biggest fan draw, and it's time to take a serious stand by toughening up its rules.
