Smith says he countered the immediate scheduling of all three schools starting in 2019 with his own proposal.

"I asked if we could start adding one at a time, getting an additional one every two years," said Smith. "We're still trying to build our program. We had two seniors and the rest are underclassmen.

"I met with the athletic director again this week and he said he had heard my thoughts on the schedule had changed. I told him, 'I would play whoever you want us to play. If that's what I need to do, that's what I will do. We aren't scared of anybody.""

Woodlee believed the conversation expressed Smith's displeasure for the scheduling.

displeasure for the scheduling. "He told me, "I'll do the scheduling, but I don't like it.' He felt we were shoving it down his throat," said Woodlee. "Those three teams are important games for our program. They are rivals and bring their fans to our games."

Woodlee added the last conversation between the pair was preempted by him asking Smith to provide a list of supplies needed to improve the cleanliness of the fieldhouse, one he asked for Monday before Tuesday's meeting. With the scheduling disagreement, the dismissal of assistant coaches and no list surfacing, Woodlee made a decision.

"I told him, 'You've been

relieved of your duties.' He said, 'You ain't nothing but a damn coward,'" recalled Woodlee. "I could have sent him an email or text, but I was looking him eye to eye.

"It was about his overall attitude and not being a team player."

Smith believed the issue was deeper, with members of the school board throwing in their influence to expedite a change.

"I feel like this came down from a place of bitterness and resentment, with people that had personal issues that couldn't be resolved," said Smith. "This is a county full of super people. Of the people I've met in Grundy County, 99.9 percent are incredibly great. I feel like there's four people controlling everything.

"When you have ultimate power, you can make people disappear."

Part of Smith's shock came from the issue of loyalty, which was questioned of him during the interview process. Smith has been hired eight times as a head coach since 2000, with his most successful stop coming at Ezell Harding, the school he led to a state championship in 2001.

Smith was named the head coach of Glencliff in January 2017, only to leave five months later due to health and family issues. He never coached a game there either.

Being loyal to the Yellow Jackets was something he was going to have to prove upon being hired, and he felt like he was taking steps to make that happen.

"I love the mountains and I grew up in the country. I wanted to finish with a school where I'm comfortable," said Smith. "Believe me or not, but I was about to buy a house here. I was planning on living here and retiring to live in a cabin.

"I know I've moved so many times that it's hard to believe, but I had made some bad decisions and was tired of job hopping. I wanted to take a program which almost lost football and make a difference. I wanted the incredible challenge."

Smith currently plans on staying in Grundy County, where he hopes the players can still accomplish great things.

"The kids were great. They never questioned anything and tried to do more than I asked. They're one of the sharpest groups of kids I've seen," said Smith. "I wish only the Yellow Jackets great luck this season. I'll be behind them all season and will help them in any way as long as I'm in Grundy County."

Woodlee announced Friday former UT linebacker Tracy Hayworth will be the new coach (more information to come in Wednesday's paper). He believes in his choice.

"When I walked out of the fieldhouse (after talking with Tracy), it was like taking 1,000 pounds off my shoulders. This was what I needed to do."
