Victim's memory cloudy in rape case

There were many ifs and uncertainties from the witness stand Thursday as day one of the rape trial against Alexander Delane began at Warren County Courthouse.

One witness testified to a night of drinking and drug use, and the victim herself couldn't remember the actual

Wednesday morning. The sixth-grader was bracing for her first day at Warren County Middle School.

saying there was some kissing and touching between the two but little more than that.

The alleged incident took place more than two years ago at a cabin in Rock Island. Several friends were staying there at the time.

Witness Madison Shirey testified she saw Delane on top of the victim late in the evening after the

victim had been put to bed by friends due to her intoxicated state. However, Shirey could not say with certainty any penetration was taking place when she saw the two.

When questioned about the events of that night, the alleged victim testified she couldn't remember many exact details. She testified to telling a friend she thought Delane was cute early in the night, then later telling that friend she did not want to go to bed with him.

She said she was alerted to the alleged rape when friends woke her up asking if she was OK. She admitted she was uncertain about what happened, although she did experience a sensation consistent with having sex.

Day two of the trial continues Friday morning with the trial expected to go to the jury on Friday.

County Commission welcomes several new faces

If experience is playing a game of hide and seek, it's found a good hiding place on the Warren County Commission.

After last week's county election, Carl E. Bouldin and Gary Prater remain as the savvy veterans of the County Commission. Bouldin has 25 years of experience, followed by Prater with 20 for a total of 45 years. That almost equals everyone else.

When new members take office Sept. 1, the remaining 22 commissioners will have a combined 50 years of experience between them.

"I don't know what to expect," said Bouldin. "It's going to be different I know that, especially with a new county executive. I don't know how he's going to organize the committees. If he asks me for advice, I'll tell him what I think. If he doesn't ask, I'll keep my mouth shut."

The massive County Commissioner turnover wasn't entirely dictated by voters. Terry Bell (16 years), opted not to seek re-election to run for county executive. Charles Morgan and Wayne Copeland (10 years each) just decided not to run again.

But several longtime commissioners were defeated at the polls, including four with 12 or more years of experience. In all, 116 years of combined experience will be leaving the County Commission on Aug. 31.
