# Aldermen face four challengers for seats

McMinnville aldermen seeking re-election in November will have to overcome a former Warren County commissioner, a former McMinnville city administrator, a seasoned candidate, and a political newcomer to keep their seats.

Up for election are seats currently held by Steve Harvey, Everett Brock and Ryle Chastain.

The four challengers include David Rutherford, who served as McMinnville city administrator for 6.5 years.

"I'm real interested in the proposed Civic Center renovation," said

Rutherford. "When I was here, the city considered a major Civic Center renovation plan in 2009 or 2010 that included an indoor pool. We paid a couple hundred thousand dollars for an architect to design those plans, but we couldn't afford the project at that time so we didn't do it. Now we're paying about \$300,000 for new plans and the renovation work doesn't even include an indoor pool. I can't believe we're going to make a decision that goes against what people have wanted for years, an indoor pool."

David Hill has sought previous positions in city government, but has yet to mount a successful campaign. Hill believes this year will be different.

"I want to give people a voice instead of electing people who do whatever they want," said Hill. "As for specific plans, I'd like to see something finally

done with the Blue Building and I'd like to see Bill Brock stay as city administrator."

When it comes to politics, this will be Sheila Younglove Miner's first race, although she has pondered running in the past.

"I have considered running for office on and off over the past few years," said Miner. "I want our city to grow and become more attractive as a place to raise a family and offer numerous activities for our citizens and tourists. Instead of sitting on the sidelines and hoping things will come to fruition, I want to be an active part of that process."

David Rhea served one term as a county commissioner for the 1st District.

He was defeated earlier this year in the May 1 primary. This will be his first run for a city government post.

"I got put out as a county commissioner but I still want to be involved and serve the community," said Rhea. "I want people to know I will be an honest and hard-working representative."

When asked about his reasons for seeking re-election, Harvey said he would like another term, "Because I enjoy serving the citizens of McMinnville by continuing to make our town a better place to live."

Ryle Chastain said, "I'd like to help keep the momentum going with all the good stuff we have going right now with city

projects, tourism, business recruitment, etc."

Everett Brock said, "We have several things started I would like to finish. The Civic Center renovation, indoor swimming pool, tourism development, city-wide recycling, and possibly a new police station. All are going to take the financial skills which I have applied over the past four years as chairman of the Finance Committee."

The seven candidates will vie for three seats. There are no districts in city elections. The top three voter-getters will be elected to serve.

The city election coincides with state and federal elections and will be held Nov. 6. Early voting begins Wednesday, Oct. 17.
