

# School board discusses options for teacher raises

Their hopes of funding teacher raises with local option sales tax money rebuffed by the county commission, the board of education is now faced with deciding whether to make the \$600 a one-time bonus or fund the amount into perpetuity in the form of raises.

"I'm for making it a raise,"

said Director of Schools Patrick Cripps after the commission rejected the school board plan of using money from the sinking fund (local option sales tax) to cover the raises that will cost over \$300,000 annually. "We have to take care of our teachers."

The funding also includes \$600 for all school staff along with teachers. With the county commission's vote to approve the budget, school employees

will be getting the increase. Teachers will also get another \$600 from the state, that part of it as part in the form of raises. The question to be determined by the board of education is whether the county's portion of the increase will be permanent.

The amount of raise/bonus has lowered dramatically as the board of education at first asked the county to help fund a \$2,400 increase for teachers. That request was rejected and

the board lowered its sights to the present \$600 amount. However, during their last meeting before the county's budget vote, the board of education decided to request the sinking fund be used. The plan met with resistance.

"At this time don't they (the school board) have six million dollars of their own money that they have not spent that they have collected from us?" posed Sixth District Commissioner

Betty Atnip just before the budget vote.

County Mayor Tim Stribling confirmed the school system has \$6.1 in the coffers, the revelation leaving the school board's request dead in the water.

With the decision of the commission, it will be up to the board of education to decide in their next meeting whether the increase will be permanent or a one-time bonus that would have to be revisited every year.

## TAXES STEADY

Among the new items being covered without a tax increase are raises for most county employees which were approved earlier this year for employees, beginning with increases for sheriff's deputies and concluding with what began as a contentious round of raises ambulance personnel which led to the resignation of Commissioner Joe Johnson when ambulance personnel were first snubbed. He eventually nixed his resignation when the raises were approved but was beaten in his bid for reelection during the Democratic Primary.

As for big ticket items be-

ing funded without raising taxes are \$165,000 to purchase and equip five new patrol cars for the sheriff's department; \$135,000 for a new ambulance; \$165,000 for a fire hall in the Four Seasons community; \$40,000 for courthouse repairs and \$10,000 for repairs to the Omega Apparel building.

As for where the property tax money goes, the budget broke it down to the penny, with the county general fund getting the biggest dip with 0.9635 cents followed by schools with 0.61 cents. General purpose capital projects get 0.10 cents and debt serve 0.13 cents. Highway and public works get 0.03 cents.

## State, federal races shaping up for November

While many paid close attention to the local races Thursday evening, some state and federal races of local importance were taking place, including that for the seat that will represent DeKalb County in Washington D.C.

John Rose handily won the Republican nomination for the 6th Congressional District, outdrawing his closest competitor, Bob Corlew by over 10,000 votes by a count of 43,768 to 33,088. Judd Matheny, long-time state representative out of Coffee County was a distant third with 16,743 votes, carrying only his home county. Lavern "Utum LaVern" Vivio pulled 9,506 while Christopher Brian Monday rounded out the field with 3,021 votes.

Rose will take on Democrat nominee Dawn Barlow who garnered 16,875 votes, more than double her closest competitor, Merrilee Wineinger with 6,828. Rose got 45 percent of the vote

in DeKalb, followed by Corlew of 30 percent and Matheny with 15 percent.

In the race for U.S. Senate, Phil Bredesen and Marsha Blackburn breezed to victory with Bredesen getting 91 percent of the Democratic vote while Blackburn took home 84 percent of Republican ballots. The numbers were right on state average here as 91 percent of Democrats voted for Bredesen while 88 percent of Republicans voted for Blackburn in DeKalb County.

Meanwhile in the run for 40th district state house, Terri Lynn Weaver is assured of another term as she bested Chad Z. Williams 8,689 to 3,289 for the Republican nomination. There is no Democrat seeking the office in November. The district includes most of DeKalb County aside from the southern portion. Weaver picked up 80 percent of the vote in DeKalb. Barlow got 44 percent of the DeKalb Democrats while Wineinger pulled 26 percent.

Clark Boyd won the Republican nomination in the 46th District which includes southern DeKalb, beating

Menda McCall Homes 9,205 to 1,757. He will take on Mark Cagle who won the Democratic Primary over Faye Northcutt-Knox 1,890 to 1,651.

In the 17th District, incumbent Republican Mark Pody had no opposition. He will face Democrat Mary Alice Carfi in November. She also had no opposition in her primary.

In the biggest Tennessee races of the night, Lee Company owner Bill Lee claimed the Republican nomination for governor while former Nashville Mayor Karl Dean ran away with the Democratic nomination.

Lee took 36 percent of the vote on the way to victory, topping Randy Body who pulled 24 percent just ahead of Diane Black who had 23 percent. Beth Harwell got 15 percent. Lee won comfortably in DeKalb, getting 42 percent of the vote ahead of 25 percent for Black and 20 percent for Boyd.

Things were not near as close for Dean who crushed Craig Fitzhugh, taking 75 percent of the vote statewide and 87 percent in DeKalb.
