A grand reopening for Our Little Shop on Thursday morning, com-

plete with a Chamber of Commerce ribbon cutting, served as a chance for the nonprofit to show off its new design. It also paid tribute to the late Emily Terrell, affectionately



called "Ms. Emily," who was the visionary behind the store's many changes and improvements.

"There were times in the past when the board actually considered closing the store, because we struggled to cover expenses," said Dawn Ardelt, the director for the Laurens County Safe Home. "But when Ms. Emily came, she always encouraged us that we needed to get our name out more, and that presentation was key. But it's a process so she didn't live to see it all come about."

Along with the ribbon cutting to reintroduce the store, a plaque was presented that honors Terrell, who

Debate to address District 55/56 consolidation

The first of three debates on a proposed consolidation of Laurens County School Districts 55 and 56 is scheduled for Tuesday night at Laurens District High School.

The debate, which will be held in the commons area at the main entrance of the school, will begin at 7 p.m. and is scheduled to end at 8:30 p.m.

State Rep. Mike Pitts (R-Laurens), who introduced a bill in the legislature seeking to consolidate the two districts this past April, and local GOP leader Keith Tripp will participate in

the debate. Pitts said he introduced the bill, which passed a floor vote on the house after being introduced as local legislation, but received quick backlash from county residents and school administrators who felt blindsided by the bill. Pitts has since pulled the bill and said he would not re-introduce it without the support of the local delegation of Rep. Mark Willis and Sen. Danny Verdin, Republicans.

"I still believe it is the right thing to do," said Pitts at a June meeting of local government and civic leaders.

Willis and Verdin said at that meeting that they would not support a consolidation effort unless it received clear support from their constituencies.

During the debate, Tripp will argue in favor of autonomy for the two districts.

"If we do our jobs right (in the debate), the winners will be the citizens of Laurens County," Tripp said in a letter to the editor published in Wednesday's edition of *The Laurens County*

"Finding the time (is tough)," Rice said. "Truthfully, the medical part is my least favorite, but it comes with the job."

Rice was working his 24-hour shift along with Capt. Deborah Waldrop, who has worked as a professional firefighter with Laurens County for some 16 years and was a volunteer with Ekom prior to starting her professional career.

"When I got into it, I wanted to help my community," Waldrop said. "I guess I wanted to make the world a better place for the community and my kids."

The new station is averaging two to four calls per day, and the vast majority of those have been medically related, Thackston said.

While the Saxon Station sits in a large rural area, it is only two minutes from I-385. It is also strategically placed to help cover the growing city of Fountain Inn and other areas in northern Laurens County.

Laurens County Administrator Jon Caime said the staffing plan for the station is more of an "urban model," but the county is looking ahead for substantial residential and industrial growth in the area that
