

OFFICIAL MOBILE COUNTY DELINQUENT TAXPAYER LIST

IF PAYMENT WAS MADE AFTER 5:00 P.M. FRIDAY, FEBRUARY 16, 2018, THE OWNER’S NAME WILL BE LISTED IN THE FOLLOWING ADVERTISEMENT.

THE FOLLOWING PROPERTIES ARE LISTED IN THE NAME OF THE OWNER OF RECORD AS OF OCTOBER 1, 2017, WHICH MAY NOT BE THE NAME OF THE CURRENT OWNER.

Property tax is due each October 1st and is delinquent after December 31st of each year. All past due accounts receive a \$5.00 penalty and begin accruing interest at a rate of 12% annually, compounded daily as of January 1st of each year.

Alabama state law requires that property owners with an unpaid tax account be notified by certified mail.

Convenience fees apply on all credit and debit card transactions. If you have selected to pay online through our secure web server, please be advised that your credit/debit card payment will be deducted from your account within three to four business days. **To make a Credit/Debit Card payment by phone, call 251-574-8530.**

NO BUSINESS, PERSONAL OR ONLINE E-CHECKS WILL BE ACCEPTED AFTER MARCH 16th. CERTIFIED FUNDS (CASH, CASHIERS CHECK OR MONEY ORDER) ARE REQUIRED FOR PAYMENT AFTER MARCH 16, 2018.

When a delinquent taxpayer fails to pay his/her property taxes on or after January 1st, the Revenue Commissioner must begin the process of preparing to sell the property to satisfy the tax lien. After all attempts required by the Code of Alabama to notify the property owner of the delinquent tax have been exhausted, the property is then offered for sale at public auction to the highest bidder. The auction will be held at the main office of the Mobile County Revenue Commission located at 3925 Michael Blvd on Monday, May 7, 2018.

Alabama state tax law requires that all delinquent tax accounts be advertised in a local publication (newspaper) for a total of (3) three times, with the first advertisement made thirty days prior to the tax sale. The costs of advertisement and certified mailing are added to unpaid property tax accounts in addition to the citation fees, penalties and interest. All delinquent property tax accounts are subject to auction if unpaid as of May 7, 2018.
